

CONCLUSIONS OF LAW

1. By (a) engaging in a conspiracy with members of Mortgage Fraud Cell No. 1 to commit offenses against the United States, including making a false statement in relation to a loan, engaging in mail fraud, engaging in wire fraud and engaging in bank fraud, in violation of 18 U.S.C. 1014, 1341, 1343 and 1344; (b) engaging in a conspiracy with members of Mortgage Fraud Cell No. 2 to commit offenses against the United States, including making a false statement in relation to a loan, engaging in mail fraud, engaging in wire fraud and engaging in bank fraud, in violation of 18 U.S.C. 1014, 1341, 1343 and 1344; (c) engaging in a conspiracy with members of Mortgage Fraud Cell No. 1 to engage in monetary transactions by through or to a financial institution, affecting interstate or foreign commerce, in criminally derived property of a value greater than \$10,000.00, such property having been derived from a specified unlawful activity in violation of 18 U.S.C. 1957; and (d) engaging in a conspiracy with members of Mortgage Fraud Cell No. 2 to engage in monetary transactions by through or to a financial institution, affecting interstate or foreign commerce, in criminally derived property of a value greater than \$10,000.00, such property having been derived from a specified unlawful activity in violation of 18 U.S.C. 1957, Smith violated Rules 8.4(b) and (c) of the North Carolina Revised Rules of Professional Conduct.

2. Smith's misconduct constitutes grounds for discipline pursuant to N.C. Gen. Stat. Section 84-28(b)(2).

IT IS NOW, THEREFORE, ORDERED:

1. Troy Anthony Smith is DISBARRED from the practice of law in North Carolina.
2. Troy Anthony Smith shall comply with the provisions of Subchapter B, Section .0124 of the Rules and Regulations of the North Carolina State Bar and shall surrender his license and permanent membership card to the Secretary of the North Carolina State Bar along with the affidavit required by Subchapter B, Section .0124.
3. The costs of this action are taxed against Troy Anthony Smith.





Troy Anthony Smith, being first duly sworn, deposes and says as follows:

1. I desire to resign and hereby tender my license to practice law in North Carolina.

2. My resignation is freely and voluntarily rendered. It is not the result of coercion or duress. I am fully aware of the implication of submitting my resignation.

3. I am aware that there is pending an investigation regarding allegations that I (a) engaged in a conspiracy with members of Mortgage Fraud Cell No. 1 to commit offenses against the United States, including making a false statement in relation to a loan, engaging in mail fraud, engaging in wire fraud and engaging in bank fraud, in violation of 18 U.S.C. 1014, 1341, 1343 and 1344; (b) engaged in a conspiracy with members of Mortgage Fraud Cell No. 2 to commit offenses against the United States, including making a false statement in relation to a loan, engaging in mail fraud, engaging in wire fraud and engaging in bank fraud, in violation of 18 U.S.C. 1014, 1341, 1343 and 1344; (c) engaged in a conspiracy with members of Mortgage Fraud Cell No. 1 to engage in monetary transactions by through or to a financial institution, affecting interstate or foreign commerce, in criminally derived property of a value greater than \$10,000.00, such property having been derived from a specified unlawful activity in violation of 18 U.S.C. 1957; and (d) engaged in a conspiracy with members of Mortgage Fraud Cell No. 2 to engage in monetary transactions by through or to a financial institution, affecting interstate or foreign commerce, in criminally derived property of a value greater than \$10,000.00, such property having been derived from a specified unlawful activity in violation of 18 U.S.C. 1957.

4. My agreement to plead guilty to these charges has been filed in the United States District Court for the Western District of North Carolina. I am in fact guilty of these charges.

5. I acknowledge the truth of the material facts upon which the investigation is predicated.

6. I am submitting my resignation because I know that if disciplinary charges were predicated upon the misconduct under investigation, I could not successfully defend against them.
