
THIS MATTER coming on to be heard and being heard by the Council of the North Carolina State Bar pursuant to 27 N.C. Admin. Code Chapter 1, Subchapter B, Rule .0117 of the Discipline and Disability Rules of the North Carolina State Bar, upon an affidavit of tender of license pursuant to Rule .0117(a) executed by David F. Tamer and filed in the offices of the North Carolina State Bar on March 8, 2000.

Based upon the affidavit, the Council finds that the conduct of David F. Tamer is grounds for discipline pursuant to N.C. Gen. Stat. Section 84-28(b)(2) in that David F. Tamer misappropriated fiduciary funds in violation of Rule 1.15-1(a), Rule 8.4(b) and Rule 8.4(c) of the North Carolina State Bar Revised Rules of Professional Conduct.

WHEREFORE, upon motion duly made and seconded, the Council enters the following order:


1. The tender of surrender of license of David F. Tamer is accepted.
2. David F. Tamer is DISBARRED from the practice of law in North Carolina.
3. David F. Tamer shall forthwith surrender his license and membership card to the Secretary. He shall comply with all provisions of 27 N.C. Admin. Code, Chapter 1, Rule .0124 of the Discipline and Disability Rules of the North Carolina State Bar.
4. The costs of this action are hereby taxed against David F. Tamer.



2. I am aware that there is pending an investigation or other proceeding regarding allegations that I misappropriated funds from three estates wherein I served as the administrator.


3. I acknowledge that the facts forming the basis of the investigation or other proceeding and referenced herein are true.
