


THIS MATTER coming on to be heard and being heard by the Council of the North Carolina State Bar pursuant to 27 N.C. Admin. Code Chapter 1, Subchapter B, Rule. 0117 of the Discipline and Disability Rules of the North Carolina State Bar, upon an affidavit of tender of license pursuant to Rule .0117(a) executed by William G. Ijames Jr. and filed in the offices of the North Carolina State Bar on July 6, 2000.

Based upon the affidavit, the Council finds that the conduct of William G. Ijames Jr. is grounds for discipline pursuant to N.C. Gen. Stat. Section 84-28(b)(2) in that William G. Ijames Jr. misappropriated estate and trust account funds in violation of Rule 1.15-1(a), Rule 1.15-2(h), Rule 8.4(b) and Rule 8.4(c) of the North Carolina State Bar Revised Rules of Professional Conduct.

WHEREFORE, upon motion duly made and seconded, the Council enters the following order:


1. The tender of surrender of license of William G. Ijames Jr. is accepted.
2. William G. Ijames Jr. is DISBARRED from the practice of law in North Carolina.
3. William G. Ijames Jr. shall forthwith surrender his license and membership card to the Secretary. He shall comply with all provisions of 27 N.C. Admin. Code, Chapter 1, Rule .0124 of the Discipline and Disability Rules of the North Carolina State Bar.
4. The costs of this action are hereby taxed against William G. Ijames Jr.

2. I am aware that there is pending an investigation or other proceeding regarding allegations that I misappropriated funds from the Henry Weir White estate and my trust account.


3. I acknowledge that the material facts forming the basis of the investigation or other proceeding and referenced herein in this affidavit are true.
