

ORDER OF REINSTATEMENT

THIS MATTER is before the Secretary of the North Carolina State Bar pursuant to a Petition for Reinstatement filed by Leroy R. Castle ("Castle") on June 30, 2008.

Based upon the petition and a review of the records of the North Carolina State Bar, the Secretary makes the following:

FINDINGS OF FACT

1. After a hearing on November 2, 2007, a hearing committee of the Disciplinary Hearing Commission ("DHC") entered Findings of Fact, Conclusions of Law, and Order of Discipline in 07 DHC 15 ("Order of Discipline") suspending Castle from the practice of law for two years with the possibility of eighteen months of the suspension being stayed if Castle complied with certain conditions.
2. On June 30, 2008, Castle filed a petition for reinstatement showing that he had satisfied the conditions of the Order of Discipline.
3. Counsel for the North Carolina State Bar did not file an objection to Castle's petition.

BASED UPON the foregoing Findings of Fact, the Secretary makes the following

CONCLUSION OF LAW


- I. The Petitioner, Leroy R. Castle, has satisfied the requirements set out in 27 NCAC 1B, § .0125(b) and is entitled to reinstatement of his license to practice law in this jurisdiction.
