This matter coming on to be heard and being heard before the Council of the North Carolina State Bar on April 17, 1992 pursuant to Section 17 of Article IX of the Rules and Regulations of the North Carolina State Bar; and based upon the affidavit executed by William J. Houck on March 31, 1992, the Council makes the following FINDINGS OF FACT:

1. Houck misappropriated funds of clients J. White Iddings and Robert Klinger.
2. Houck misappropriated funds from the trust account of Joe Cagle, Attorney at Law.
3. Houck commingled personal funds with clients' funds in his trust account.
4. Houck neglected client matters.

BASED UPON the admissions in Houck's affidavit, the Council concludes that Houck violated N. C. Gen. Stat. Sec. 84-28(b)(2) by violating Rules 1.2(B) and (C), 10.1(A) and (C), and 6(B)(3) of the Rules of Professional Conduct.

WHEREFORE, upon motion being duly made and seconded, the Council enters the following ORDER:

1. The tender of surrender of license of William J. Houck should be accepted.
2. William J. Houck is hereby DISBARRED from the practice of law in North Carolina.
3. That the costs of this action are taxed to William J. Houck as assessed by the Secretary.

Co-mingling of client and personal funds in my trust accounts.


Neglect of client interests and cases.
