This matter coming on to be heard and being heard before the Council of the North Carolina State Bar on July 17, 1992 pursuant to Section 17 of Article IX of the Rules and Regulations of the North Carolina State Bar; and based upon the affidavit executed by John P. Siskind on May 18, 1992, the Council makes the following FINDINGS OF FACT:


1. Siskind mishandled fiduciary funds entrusted to him in violation of Canon I and Canon X of the Rules of Professional Conduct in the matter of Ralph N. Colvard.
2. Siskind mishandled fiduciary funds entrusted to him in violation of Canon I and Canon X of the Rules of Professional Conduct in the matter of the Estate of Thomas Westbrook.

BASED UPON the admissions in Siskind's affidavit, the Council concludes that Siskind violated North Carolina General Statute Section 84-28(b)(2) by violating Rule 1.2 and Rule 10.1 of the Rules of Professional Conduct.

WHEREFORE, upon motion be duly made and seconded, the Council enters the follow ORDER:

1. The tender of surrender of license of John P. Siskind should be accepted.
2. John P. Siskind is hereby DISBARRED from the practice of law in North Carolina.
3. That the costs of this action are taxed to John P. Siskind as assessed by the Secretary.

AFFIDAVIT


TO: The Council of The North Carolina State Bar


