JUDGMENT SUSPENDING SENTENCE

In open court, the defendant appeared for trial upon the charge or charges of Embezzlement

and thereupon entered a plea of no contest.


Having plead no contest ~~guilty~~ of the offense of Embezzlement

which is a violation of G.S. 14-90 and of the grade of felony.

It is ADJUDGED that the defendant be imprisoned for the term of five (5) years
in the State Prison.

The execution of this sentence is suspended, however, for five years upon compliance with the following conditions, to which the defendant gave assent: that he pay the cost; that he turn over to the Clerk of Superior Court or surrender to the Clerk of Superior Court his license to practice law in this State and that he not practice law in North Carolina until duly licensed by the North Carolina State Bar or its successors; that he not violate any State or Federal Laws.
