CONSENT ORDER  
TRANSFERRING MEMBER TO  
DISABILITY INACTIVE  
STATUS

---

THIS MATTER is before the undersigned Chairperson of the Grievance Committee of the N.C. State Bar pursuant to 27 N.C. Admin. Code Chapter 1B, Section .0118(g). Nichole P. McLaughlin represents the North Carolina State Bar and Orrin R. Robbins appeared pro se. Based upon facts presented and with the consent of the member and of the counsel, the undersigned makes the following:

#### FINDINGS OF FACT

1. The North Carolina State Bar is a body duly organized under the laws of North Carolina and is the proper party to consent to this proceeding under the authority granted it in Chapter 84 of the General Statutes of North Carolina and the Rules and Regulations of the North Carolina State Bar promulgated thereunder.
2. Orrin R. Robbins was admitted to practice law in North Carolina on August 19, 1988 and is an Attorney at Law licensed to practice in North Carolina, subject to the rules, regulations and Revised Rules of Professional Conduct of the North Carolina State Bar and the laws of the State of North Carolina.
3. Orrin R. Robbins actively engaged in the practice of law in the State of North Carolina and maintained a law office in Orange County, North Carolina.
4. Orrin R. Robbins currently suffers from post traumatic stress disorder.
5. The above condition significantly impairs Orrin R. Robbins' professional judgment, performance or competence as an attorney.
6. Orrin R. Robbins consents to being transferred to disability inactive status.

BASED UPON the foregoing Findings of Fact, the undersigned makes the following:

CONCLUSIONS OF LAW

1. Pursuant to 27 N.C. Admin. Code 1B Section .0118(g), the proper parties have consented to the transfer of Orrin R. Robbins to disability inactive status.
2. Orrin R. Robbins is disabled within the meaning of 27 N.C. Admin. Code 1B Section .0103(18).

THEREFORE, it is hereby ORDERED:


1. Orrin R. Robbins is transferred to disability inactive status.
2. Orrin R. Robbins shall refrain from practicing law in North Carolina until reinstated to active status pursuant to 27 N.C. Admin. Code Chapter 1B Section .0125(c).
