RESOLUTION OF REINSTATEMENT OF  
CERTIFICATE OF LICENSE TO PRACTICE LAW

The following Resolution was adopted by the Council of The North Carolina State Bar at its meeting on January 13, 1978.

IN THE MATTER OF WALTON PETER BURKHIMER, Petitioner,  
Lenoir, Caldwell County, North Carolina:

It appearing to the Council of The North Carolina State Bar that a hearing on the application and petition for reinstatement of Walton Peter Burkhirer came on to be heard, and was heard, on December 9, 1977 before a Hearing Committee of The Disciplinary Hearing Commission in the office of The North Carolina State Bar in Raleigh, North Carolina. The members of the Hearing Committee, after having heard the evidence, examined the exhibits filed on behalf of the Petitioner and on behalf of The North Carolina State Bar and having heard argument of Counsel filed its Findings, Conclusions and Recommendations on December 9, 1977, recommending that the license of Walton Peter Burkhirer to practice law in the State of North Carolina be restored to him.

It appearing to the Council of The North Carolina State Bar that Walton Peter Burkhirer was disbarred from the practice of law by Order of the Honorable William J. Bundy in the Superior Court of New Hanover County on December 4, 1956.

And it further appearing to the Council that on September 28, 1977, Walton Peter Burkhirer filed with the office of The North Carolina State Bar a petition for the reinstatement of his certificate to practice law in North Carolina; and the Council finds from the petition and based upon the affidavits filed in support of said petition that Walton Peter Burkhirer has complied with all conditions set forth in the Judgment and

Order of the Superior Court of New Hanover County of December 4, 1956; and that Walton Peter Burkheimer has demonstrated by clear and convincing evidence that he has the moral qualifications, competency and learning in law required for admission to practice law in this State and that the resumption of the practice of law within the State by the Petitioner will neither be detrimental to the integrity and standing of The North Carolina State Bar or the administration of justice nor subversive to the public interest.


NOW, THEREFORE, BE IT RESOLVED that Walton Peter Burkheimer heretofore disbarred by the Superior Court of New Hanover County be reinstated as an attorney at law with the rights and privileges to practice law in North Carolina.

The Secretary is hereby directed to authorize the Board of Law Examiners to issue a certificate of license to Walton Peter Burkheimer in accordance with N.C.G.S. 84-24.

The Secretary is further directed to forward a copy of this Resolution to the Supreme Court of North Carolina, the Court of Appeals of North Carolina and the Clerk of Superior Court of Caldwell County.

BE IT FURTHER RESOLVED that the Petitioner is taxed with the cost of this proceeding as certified by the Secretary.
