ORDER OF REINSTATEMENT

This matter coming on to be heard and being heard on July 16, 1982 by the Council of the North Carolina State Bar pursuant to Section 25(4) of Article IX of the Rules and Regulations of the North Carolina State Bar; and

Harry DuMont having filed with the Secretary of the North Carolina State Bar a petition for reinstatement of his license on June 14, 1982; and

There being no offer of proof to the contrary, the Council finds, as represented by Harry DuMont, the following:

1. The petitioner is a citizen and resident of Buncombe County, North Carolina, and in 1947 was licensed to practice law in the State of North Carolina and was admitted to the North Carolina State Bar. Thereafter, he was actively engaged in the practice of law until January, 1982.

2. On April 9, 1980, a Hearing Committee appointed by the North Carolina Disciplinary Hearing Commission entered an Order suspending the petitioner from the practice of law for a period of six months. On appeal this was affirmed by the North Carolina Court of Appeals (State v. DuMont, 52 N.C.App. 1). The North Carolina Supreme Court granted certiorari and on January 12, 1982 filed its opinion affirming the holding of the Court of Appeals, (State Bar v. DuMont, 304 N.C. 627 - Advance Sheet issued April 15, 1982).

3. On January 29, 1982, the petitioner undertook compliance with the order of suspension and promptly notified the Secretary of the State Bar.

4. The petitioner has, since January 29, 1982, fully complied with the Trial Committee's Order of April 19, 1980, and has agreed to continue to do so during the entire period of suspension.

NOW, THEREFORE, UPON MOTION DULY MADE AND SECONDED, IT IS HEREBY ORDERED:


1. That Harry DuMont be reinstated as an Attorney at Law with the rights and privileges to practice law in North Carolina effective July 29, 1982.

2. That on July 29, 1982 the Secretary of the North Carolina State Bar is directed to restore and deliver to the petitioner the Certificate of License now in possession of the Secretary.

3. That on July 29, 1982 the Secretary forward a copy of this Order to the Supreme Court of North Carolina, the Court of Appeals of North Carolina, the Clerk of Superior Court of Buncombe County and all other Courts of Law notified previously of Harry DuMont's suspension.

4. That Harry DuMont be taxed with the costs of this proceeding as certified by the Secretary.
