ORDER OF REINSTATEMENT

C. C. MALONE, JR.

This matter coming on to be heard and being heard on October 21, 1982 by the Council of The North Carolina State Bar pursuant to Section 25(4) of Article IX of the Rules and Regulations of The North Carolina State Bar; and

C. C. Malone, Jr. having filed with the Secretary of The North Carolina State Bar a Petition for Reinstatement of his license on October 6, 1982; and

There being no offer of proof to the contrary, the Council finds, as represented by C. C. Malone, Jr., the following:

1. The petitioner is a citizen and resident of Durham County, North Carolina, and in 1961 was licensed to practice law in the State of North Carolina and was admitted to The North Carolina State Bar. Thereafter, he was actively engaged in the practice of law until October 1, 1982.

2. On August 20, 1982, a Hearing Committee appointed by The North Carolina Disciplinary Hearing Commission entered an Order suspending the petitioner from the practice of law for a period of 60 days commencing on October 1, 1982.

3. On October 1, 1982, the petitioner undertook compliance with the Order of Suspension and on October 6, 1982, filed an affidavit with the Secretary of the State Bar in compliance with Section 24 of the aforesaid Rules.

4. The petitioner has, since October 1, 1982, fully complied with the Trial Committee's Order of August 20, 1982, and has agreed to continue to do so during the entire period of suspension.


NOW, THEREFORE, UPON MOTION DULY MADE AND SECONDED, IT IS HEREBY ORDERED:

1. That, contingent upon payment of all costs related to his suspension and reinstatement and the submission of an affidavit from the Petitioner demonstrating his continued compliance with the Order of Suspension, C. C. Malone, Jr. be reinstated as an Attorney at Law with the rights and privileges to practice law in North Carolina effective December 1, 1982.

2. That, on December 1, 1982, the Secretary forward a copy of this Order to the Supreme Court of North Carolina, the Court of Appeals of North Carolina, the Clerk of Superior Court of Durham County and all other Courts of Law notified previously of C. C. Malone's suspension.

3. That, C. C. Malone, Jr. be taxed with the costs of this proceeding as certified by the Secretary.
