RESOLUTION OF REINSTATEMENT OF CERTIFICATE OF LICENSE TO PRACTICE LAW

The following Resolution was adopted by the Council of The North Carolina State Bar at its meeting on October 16, 1980.

IN THE MATTER OF WILLIAM R. WINDERS, Petitioner, Durham, Durham County, North Carolina:

It appearing to the Council of The North Carolina State Bar that William R. Winders was suspended from the practice of law for a period of eighteen months commencing December 21, 1979, by Order of the Council dated April 30, 1980;

And it further appearing to the Council that William R. Winders filed with The North Carolina State Bar a Petition for the Reinstatement of his certificate to practice law in North Carolina;

And the Council finds from the Petition and from representations by counsel for William R. Winders, James Maxwell of the Durham County Bar, that:

1. William R. Winders has paid the costs of the hearing which resulted in the suspension of his license to practice law.
2. William R. Winders has now been paroled from incarceration with the United States Department of Justice and that said parole was effective after service of seven months of active incarceration on July 26, 1980,
3. William R. Winders has returned to Durham, North Carolina and desires to be reinstated to the practice of law as provided in Section 25 of the Discipline and Disbarment Rules of The North Carolina State Bar,
4. William R. Winders was duly licensed to practice law in the courts of the State of North Carolina on April 3, 1951,
5. William R. Winders was engaged in the general practice of law in North Carolina from April 17, 1951, until December 21, 1979, at which date he tendered his license and resignation to The North Carolina State Bar Council;

And the Council finds that William R. Winders has the moral qualifications, competency and learning in the law required for the admission to the practice of law in this state, and that the resumption of the practice of law within the state by William R. Winders will be neither detrimental to the integrity and standing of the Bar or the administration of justice nor subversive of the public interest.


NOW, THEREFORE, BE IT RESOLVED that William R. Winders, heretofore suspended from the practice of law by the Council of The North Carolina State Bar, be reinstated as an attorney at law with the rights and privileges to practice law in North Carolina;

The Secretary is hereby directed to restore and deliver to the Petitioner, the certificate of license now in possession of the Secretary;

The Secretary is further directed to forward a copy of this Resolution to the Supreme Court of North Carolina, the Court of Appeals of North Carolina, the Clerk of Superior Court of Durham County, and all other Courts of Law notified previously of William R. Winders suspension.

BE IT FURTHER RESOLVED that the Petitioner is taxed with the cost of this proceeding as certified by the Secretary.
