ORDER OF REINSTATEMENT

THIS MATTER is before the Secretary of the North Carolina State Bar pursuant to a Petition for Reinstatement filed by Hilda Burnett-Baker on Nov. 13, 1998.

Based upon a review of the records of the North Carolina State Bar, the Secretary makes the following:

FINDINGS OF FACT

1. The Supreme Court of New Jersey entered an order of discipline dated Oct. 15, 1997, suspending Hilda Burnett-Baker from the practice of law in New Jersey for three months.
2. On July 22, 1998, the Grievance Committee of the North Carolina State Bar entered an order of reciprocal discipline pursuant to 27 N.C. Admin. Code Chapter 1, Subchapter B, § .0116(b). The Grievance Committee's order suspended Hilda Burnett-Baker from the practice of law in North Carolina for three months.
3. The order suspending the license of Hilda Burnett-Baker became effective on Aug. 4, 1998.
4. The three-month suspension of Hilda Burnett-Baker's license ended on Nov. 4, 1998.
5. On Nov. 13, 1998, Hilda Burnett-Baker filed a verified petition in which she stated that she had complied with the requirements for reinstatement. Ms. Burnett-Baker amended her petition on Nov. 18, 1998.
6. The counsel of the N.C. State Bar has not filed an objection to Hilda Burnett-Baker's petition for reinstatement of her license to practice law pursuant to 27 N.C.

Admin. Code Chapter 1, Subchapter B, § .0125 of the Discipline & Disbarment Rules of the N.C. State Bar.

7. Hilda Burnett-Baker has paid her 1998 mandatory N.C. State Bar dues.

BASED UPON the foregoing Findings of Fact, the Secretary makes the following

CONCLUSION OF LAW

The Petitioner, Hilda Burnett-Baker has satisfied the requirements set out § .0125(b) of the Discipline & Disbarment Rules of the N.C. State Bar.

THEREFORE, pursuant to §.0125 of the Discipline & Disbarment Rules of the N.C. State Bar, it is hereby ordered:

1. Hilda Burnett-Baker is hereby reinstated to the practice of law in North Carolina effective Dec. 13, 1998.
2. Hilda Burnett-Baker's N.C. State Bar membership card and law license shall be returned to her.
