

ORDER OF PERMANENT DISBARMENT

STEWART L. CLOER, et al
Defendants,

After considering the evidence presented as well as the arguments of the attorneys for the Plaintiff, **THE COURT MAKES THE FOLLOWING FINDINGS OF FACT:**

1. That the Court has jurisdiction over the parties and the subject matter hereto and the issue of Permanent Disbarment of Stewart L. Cloer is properly before the Court.

2. That the Judgment filed on April 9, 1999 is incorporated herein by reference as if fully set forth herein.

3. Defendant Stewart L. Cloer committed criminal acts that reflect adversely on his honesty, trustworthiness, and fitness as a lawyer.

4. Defendant Stewart L. Cloer engaged in conduct involving dishonesty, fraud, deceit and misrepresentation.

5. Stewart L. Cloer engaged in acts which were prejudicial to the administration of justice and he intentionally prejudiced and damaged his client during the course of a professional relationship.

BASED UPON THE FOREGOING FINDINGS OF FACT AND CONCLUSIONS OF LAW, IT IS ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1. That Stewart L. Cloer be, and he is, permanently barred from practicing of law in the State of North Carolina.

2. Stewart L. Cloer is hereby ordered to surrender his license to practice law in the State of North Carolina, any and all membership cards, and State Bar identification cards to the North Carolina State Bar by mailing them, within five (5) days of service of this Order, certified mail, return receipt requested, which said return receipt shall be addressed as follows:


