THIS MATTER is before the undersigned Chairperson of the Grievance Committee of the N.C. State Bar pursuant to 27 N.C. Admin. Code Chapter 1B, Section .0118(g). Carolin Bakewell represents the North Carolina State Bar and Phaedra Kelly appeared pro se. Based upon the evidence submitted by Kelly and with the consent of the parties hereto, the undersigned makes the following:

FINDINGS OF FACT

1. The North Carolina State Bar is a body duly organized under the laws of North Carolina and is the proper party to consent to this proceeding under the authority granted it in Chapter 84 of the General Statutes of North Carolina and the Rules and Regulations of the North Carolina State Bar promulgated thereunder.

2. Phaedra A. Kelly was admitted to practice law in North Carolina on Aug. 21, 1999 and is an Attorney at Law licensed to practice in North Carolina, subject to the rules, regulations and Revised Rules of Professional Conduct of the North Carolina State Bar and the laws of the State of North Carolina.

3. Phaedra A. Kelly actively engaged in the practice of law in the State of North Carolina and, prior to June 6, 2003 maintained a law office in the City of Chapel Hill, Orange County, North Carolina.

4. Kelly currently suffers from a depressive disorder which significantly impairs her professional judgment, performance or competence as an attorney.

5. Kelly consents to being transferred to disability inactive status.

BASED UPON the foregoing Findings of Fact, the undersigned makes the following:

CONCLUSIONS OF LAW

1. Pursuant to 27 N.C. Admin. Code 1B Section .0118(g), the proper parties have consented to the transfer of Phaedra A. Kelly to disability inactive status.

2. Phaedra A. Kelly is disabled within the meaning of 27 N.C. Admin. Code 1B Section .0103(18).

THEREFORE, it is hereby ORDERED:

1. Phaedra A. Kelly is hereby transferred to disability inactive status.

2. Phaedra A. Kelly shall refrain from practicing law in North Carolina until reinstated to active status pursuant to 27 N.C. Admin. Code Chapter 1B Section .0125(c).
