CONSENT ORDER OF DISBARMENT

THIS MATTER came before the undersigned Judge of Superior Court of Wake County. Petitioner, the North Carolina State Bar, was represented by Brian P.D. Oten. Respondent, Scott Justin McCormick, represented himself.

Based upon the Affidavit of Surrender of Law License submitted to the Court by Respondent, Scott Justin McCormick, and the consent of the parties, the Court makes the following:

FINDINGS OF FACT

1. Respondent, Scott Justin McCormick ("McCormick"), was licensed to practice law in North Carolina on 28 August 2009 and is, and was at all times referred to herein, an attorney at law licensed to practice in North Carolina, subject to the rules, regulations, and Rules of Professional Conduct of the North Carolina State Bar and the laws of the State of North Carolina.

2. During the periods relevant hereto, McCormick was engaged in the practice of law in Winston-Salem, Forsyth County, North Carolina.

3. In October 2013, McCormick received \$350.00 from client Simcox for representation in a traffic matter. This payment included anticipated court costs and fines, which were entrusted funds, as well as attorney fees for the representations. McCormick did not deposit these funds into his trust account; rather, he deposited the funds into his operating account. McCormick subsequently utilized the funds for his own personal benefit or for the benefit of third parties without authorization to do so from the beneficial owner of the funds.

4. From at least January 2013 through June 2014, McCormick intentionally deposited entrusted client funds into his business operating account, transferred entrusted client funds out of his attorney trust account and into his business account without regard for whether he was entitled to the funds, and knowingly failed to track or account for his receipt and disbursement of entrusted client funds. McCormick misused entrusted client funds by disbursing at least \$2,833.84 of entrusted client funds from his trust account for

his personal benefit or for the benefit of third parties without any knowledge or evidence that such disbursements were justified.

5. McCormick desires to resign his license to practice law and has tendered his license to practice law in North Carolina.

6. McCormick's resignation is freely and voluntarily rendered. It is not the result of coercion or duress. McCormick is fully aware of the implication of submitting his resignation.

7. McCormick is aware that there is presently pending an investigation with the North Carolina State Bar regarding the conduct described above. McCormick acknowledges that the material facts upon which the State Bar's investigation is predicated are true.

8. McCormick has submitted his resignation because he knows that if disciplinary charges were predicated upon the misconduct under investigation, he could not successfully defend against them.

Based upon the foregoing Findings of Fact and the consent of the parties, the Court makes the following

CONCLUSIONS OF LAW

1. By misappropriating entrusted client funds, McCormick used entrusted funds for his personal benefit or for the benefit of third parties not entitled to the funds in violation of Rules 1.15-2(a), (b), and (j), and engaged in conduct involving dishonesty, fraud, deceit, or misrepresentation in violation of Rule 8.4(c) of the Rules of Professional Conduct.

2. McCormick's misconduct constitutes grounds for discipline pursuant to N.C. Gen. Stat. § 84-28(b)(2).

3. The courts of this State have inherent authority to take disciplinary action against attorneys licensed to practice law in North Carolina.

4. This Court has jurisdiction over the person of Scott Justin McCormick and over the subject matter of this proceeding.

5. McCormick has engaged in professional misconduct warranting disbarment.

IT IS NOW, THEREFORE, **ORDERED**:

1. Scott Justin McCormick is **DISBARRED** from the practice of law in North Carolina.

2. McCormick shall comply with the provisions of 27 N.C. Admin. Code, Chapter 1, Subchapter B, Section .0124 of the Rules and Regulations of the North Carolina State Bar and shall surrender his license and permanent membership card to the Secretary of the North Carolina State Bar along with the affidavit required by § .0124. McCormick shall have thirty (30) days from the date of the entry of this order to complete the requirements of § .0124.

3. McCormick shall not petition for reinstatement of his law license until the expiration of at least five years from the date of entry of this order.

4. McCormick's law license shall not be reinstated until he has demonstrated to the satisfaction of the Disciplinary Hearing Commission and the Council of the North Carolina State Bar that he has complied with 27 N.C. Admin. Code, Chapter 1, Subchapter B, Section .0125 of the Rules and Regulations of the North Carolina State Bar.

5. The costs of this action are taxed against McCormick.




Scott Justin McCormick, being first duly sworn, deposes and says as follows:
