

Registration of an Interstate/International Law Firm

Application processing time is 3-5 business days from date of receipt.

The following documents and fees must be submitted to register an interstate/international law firm with the North Carolina State Bar:

- (1) The original Interstate /International Law Firm Registration Statement (attached.) Please note that the statement must be notarized.
- (2) \$500.00 check or money order payable to NC State Bar.

Once your registration statement is approved, we will email a Certificate of Registration for your records and a Certification of Registration for submission to the NC Secretary of State's Office (NC SOS), when applying for a Certificate of Authority to Transact Business in NC (a certificate of authority is required to transact business in NC). The Application for a Certificate of Authority (Form PC-01 for PA/PCs or Form PLLC-01 for PLLCs) can be found on the NC SOS website:
