# OFFICE OF COUNSEL

The Office of Counsel is the legal department of the North Carolina State Bar. The office receives and handles complaints concerning lawyer misconduct and the unauthorized practice of law. The Office of Counsel consists of disciplinary staff, the authorized practice staff, the investigations department and the Attorney/Client Assistance Program (ACAP) staff. The disciplinary staff receives, investigates and, where necessary, litigates claims of professional misconduct and disability against North Carolina lawyers. The office assists the Authorized Practice Committee to investigate and resolve complaints concerning the unauthorized practice of law by non-lawyers. It also represents the State Bar in the federal and state trial courts and in federal and state appellate courts. The office provides legal counsel to the Client Security Fund Board of Directors, pursues subrogation actions for recovery of funds paid by the CSF and disburses funds from the trust accounts of deceased, disabled and disbarred lawyers. It also provides legal opinions on issues of interest to departments and committees of the State Bar.

The ACAP staff helps members of the public resolve problems with lawyers other than matters involving potentially serious violations of the Revised Rules of Professional Conduct. The ACAP staff also provides information about the grievance process, the courts and justice system and helps resolve fee disputes between lawyers and their clients.

The Office of Counsel includes twelve lawyers, one administrator, four paralegals, three administrative assistants and eleven investigators, including four financial auditors. The ACAP staff includes its director, who is also a fee dispute mediator, a second fee dispute mediator, an administrative assistant and three public liaisons.

The Office of Counsel is located in the State Bar Building, 208 Fayetteville Street, Raleigh, N.C. 27601. The Office of Counsel is open from 9 a.m. until 5 p.m. on weekdays and may be reached at 919-828-4620. Each staff person's telephone extension appears on pages two and three of this report.

# 2008 ANNUAL REPORT OFFICE OF COUNSEL THE NORTH CAROLINA STATE BAR

# **Attorney Client Assistance Program**

The Attorney/Client Assistance Program ("ACAP") is comprised of six staff members; three public liaisons, two mediators and one administrative assistant. During 2008, the staff responded to a total of 19,452 calls from members of the general public, a slight decrease over the 21,110 received in 2007. As a result of those calls, 3,646 lawyers were contacted in an attempt to resolve a concern expressed by the client. Additionally, the ACAP staff responded to 2,416 letters from inmates and the general public regarding representation provided by a lawyer. Staff also responded to 596 email messages from the general public requesting information. A graph summarizing call data for the last several years appears on page 18.

This past year there were 785 fee dispute resolution files opened with the State Bar; 122 of these requests were sent to one of the four judicial districts that have fee dispute committees, 39 were filed locally and monitored by the State Bar, and the remaining 624 files were investigated and mediated, when appropriate, by ACAP mediators. A graph summarizing the number of fee dispute cases handled by the State Bar since 1994 appears on page 19.

# **Authorized Practice Committee**

The Authorized Practice Committee opened 115 files in 2008, compared to the 120 files opened in 2007. The Committee resolved 131 files during 2008.

In March 2008, the State Bar obtained a permanent injunction against disbarred West Virginia lawyer P. Lee Clay to prevent him from practicing immigration law in North Carolina. Clay had been a long-time resident of North Carolina and handled only immigration matters before he was disbarred by the West Virginia State Bar.

The Office of Counsel completed the litigation initiated jointly by the State Bar and the Attorney General in Wake County Superior Court against American Family Legal Plans ("AFLP"). On July 1, 2008, the Wake County Superior Court entered a permanent injunction prohibiting AFLP from marketing a purported prepaid legal service plan that targeted seniors with a sales pitch to purchase revocable living trusts.

In September 2008, the Office of Counsel began negotiating a consent injunction against a Charlotte area real estate closing firm, Mid-Atlantic Title. During negotiations, the office learned that Mid-Atlantic Title had gone out of business. The office is still working with counsel for Mid-Atlantic to finalize a consent injunction.

Also in September 2008, the office began negotiating a consent injunction against a Florida business, Law's Specialty Group, that prepares deeds for real property transactions nationwide. Counsel hopes to complete negotiations in early 2009.

# **Grievance Committee Actions**

During calendar year 2008, a total of 1,543 grievance files were opened by the State Bar and the district bar offices, compared with the 1,464 files opened in 2007. A chart summarizing grievances files opened each year since 1986 appears on page 20.

All grievances received by the State Bar must be considered and acted upon by one or more members of the Grievance Committee. The Committee considered a total of 1,663 grievances during 2008. Of those, 1,350 were dismissed. Twenty cases were dismissed and retained because the respondent lawyers are disbarred and one file was abated because the respondent lawyer has been transferred to disability inactive status. These numbers represent about 82 percent of the grievances considered by the Committee. In addition to the grievances that were dismissed outright in 2008, 30 grievances were dismissed with letters of caution and another 67 grievances were dismissed with letters of warning.

In 2008, the Grievance Committee issued admonitions in 39 cases, reprimands in 51 cases and censures in 12 cases. Fifty six cases were referred for trial before the Disciplinary Hearing Commission (DHC). For the year, a total of 255 grievances resulted in imposition of discipline by the Grievance Committee or referral to the DHC. That figure represents approximately 15 percent of the grievances considered by the Committee in 2008. The Chair of the Grievance Committee also disbarred one lawyer by reciprocal discipline and transferred four lawyers to disability inactive status. The Committee referred seven lawyers to the Lawyer's Assistance Program.

An itemized report detailing the disposition of grievances considered by the Committee in 2008 begins on page 15.

# **Disciplinary Hearing Commission Cases**

# 1. <u>Disciplinary and Disability Cases</u>

The DHC is the independent tribunal which hears lawyer disciplinary cases. The 20-member Commission hears cases involving alleged violations of the Revised Rules of Professional Conduct, cases in which it is alleged that a lawyer is disabled, petitions from disbarred and suspended lawyers seeking reinstatement to the practice of law and show cause petitions alleging that a lawyer has violated a prior DHC order. Each case is heard by a panel of three consisting of two lawyers and one layperson.

During 2008, the Office of Counsel completed a total of 41 disciplinary, reinstatement and show cause cases before the DHC. Of those, 29 were resolved by trial and 11 by consent. One case was dismissed with prejudice. In 2007, the Office of Counsel completed 27 such cases. Of those, seven were resolved by consent and 20 were tried.

In 2008, the DHC entered seven orders of disbarment. In five of those cases, the lawyer misappropriated money from clients or from a law firm. One case involved neglect, failure to communicate and non-compliance with U.S. District Court discovery obligations. In the seventh case, the lawyer facilitated numerous fraudulent real estate transactions by making false representations on HUD-1 Settlement Statements.

In 2008, the DHC imposed three active suspensions, seven suspensions in which the lawyer could seek a stay after serving some period of active suspension and six suspensions entirely stayed upon compliance with various conditions. Three lawyers' stayed suspensions were activated after show cause hearings. The DHC censured two lawyers, reprimanded one lawyer and admonished one lawyer for less serious Rule violations. The DHC transferred four lawyers to disability inactive status.

# 2. Reinstatement Cases

In 2008, the DHC reinstated one lawyer from disability inactive status and reinstated two lawyers from active disciplinary suspension. The DHC denied one lawyer's petition to

stay the suspension of his license. Two petitions for reinstatement from disbarment were filed in 2008. The DHC denied both petitions.

### **Actions Before the State Bar Council**

# 1. Tenders of Surrender of License

In 2008, two lawyers surrendered their law licenses to the Council and were disbarred. Both misappropriated entrusted funds. Three lawyers surrendered their law licenses and were disbarred by the Council during 2007.

# 2. Reinstatement Proceedings

The State Bar Council did not hear any reinstatement cases in 2008. The last time the Council considered a reinstatement case was in 2000.

# **Actions Before the Secretary**

The Secretary receives reinstatement petitions from lawyers whose licenses are suspended for disciplinary violations and enters reinstatement orders in uncontested cases. Contested cases are referred to the DHC for trial.

Five lawyers filed reinstatement petitions with the Secretary in 2008. Three petitions were granted without opposition and without a hearing. Two were heard before the DHC.

# **Actions Before the State Trial Courts**

# 1. Judicial Disbarments

In 2008, eight lawyers surrendered their law licenses and were disbarred by the Wake County Superior Court. Six misappropriated entrusted funds and two participated in fraudulent real estate transactions. In 2007, two lawyers surrendered their licenses to the Superior Court and were disbarred.

# 2. <u>Judicial Suspensions</u>

One lawyer was suspended by the Superior Court for one year. The lawyer was convicted of the felony offense of manufacturing, selling, delivering or possessing with the intent to manufacture, sell or deliver a Schedule 1 controlled substance. The State Bar has initiated a DHC action against that lawyer.

# 3. Injunction Proceedings

During 2008, the Office of Counsel obtained injunctions barring 14 lawyers from handling entrusted funds. The Office of Counsel obtained injunctions against five lawyers in 2007 and 10 lawyers in 2006.

# 4. <u>Appointment of Trustees for Law Practices of Missing,</u> <u>Deceased, Disabled & Disbarred Attorneys</u>

In 2008, the Office of Counsel petitioned the courts to appoint trustees to wind down the practices of seven lawyers. Of that number, one lawyer was missing or had abandoned her practice and six lawyers had died. The Office of Counsel also arranged an informal trusteeship for a disabled lawyer. The State Bar filed seven trustee petitions in 2007.

# 5. <u>Disciplinary and Disability Cases in the State Trial Courts</u>

On February 18-19, 2008, Gaston County Superior Court held a hearing to determine whether James Stroud should be reinstated to active practice. The court had transferred Stroud involuntarily to disability inactive status in 2007 due to a disastrous manic episode after he failed to take prescribed medications for bipolar disorder. Stroud's original petition for reinstatement was denied. Upon reconsideration, the court reinstated Stroud upon very specific conditions, including that Stroud is only permitted to practice law in New Hanover, Pender, Brunswick and Onslow Counties as an associate employed by Wilmington lawyer Bruce H. Jackson, Jr., who will closely supervise Stroud.

# 6. Miscellaneous

As usual, in 2008 the State Bar was a party to numerous actions in the State courts. The Office of Counsel represented the State Bar in many of these actions.

The State Bar intervened in *Shuford & Hunter*, *P.A. f/k/a Shuford*, *Hunter and Brown*, *P.A. v. Thomas and Jane Brown* in Cabarrus County Superior Court. Brown, who practiced in Charlotte but lived in Concord, was disbarred in March 2008, after he admitted misappropriating at least \$970,000.00 from his firm's trust account. Brown's former law partners filed a lawsuit to seize all of Brown's and his wife's assets. Those assets will be liquidated and the proceeds disbursed to Brown's wronged clients under the court's supervision. The Client Security Fund has already paid some claims and expects to pay others. The Office of Counsel intervened to position the CSF to receive reimbursement for CSF payments. Because more parties continue to join the action, pleadings are still open. A hearing on the addition of new parties is scheduled for February 16, 2009.

In 2008, the office filed nine cases in district and superior courts seeking reimbursement from disbarred lawyers for Client Security Fund payments.

The office appeared in Wake County Superior Court to obtain permission to disburse funds from the trust accounts of 12 disbarred, deceased or disabled lawyers.

The Attorney General represented the State Bar and the DHC in a Tort Claims Act action filed by Robert Talford. Talford contends the State Bar and the DHC acted wrongfully in disbarring him. The order of disbarment was later reversed on appeal. On October 7, 2008, the full Industrial Commission affirmed the deputy commissioner's dismissal of the claims

under the public duty doctrine. Talford's time to appeal recently expired. The case is therefore concluded.

The Attorney General also represented the State Bar in a Tort Claims Act action filed by Angela Dozier. Dozier sued the State Bar, Lawyers Mutual and her former lawyer for \$3 million, but did not articulate for what acts or omissions. The State Bar's motion to dismiss was allowed and Dozier did not appeal within the time allowed. The case is therefore concluded.

Special Deputy Attorney General Alec Peters represents the State Bar, Tom Lunsford and present and former members of the Administrative Committee in a lawsuit in Wake County Superior Court challenging the constitutionality of the \$50 surcharge. The case is captioned El-Khouri et al v. N.C. State Bar et al. The plaintiffs are three public defenders from Charlotte who challenged the surcharge unsuccessfully before the Administrative Committee. They seek refunds of their \$50 payments, interest, a declaratory judgment that the statute is unconstitutional, injunctive relief and attorney fees. Peters represented the State Bar in the federal \$50 surcharge litigation, Jackson et al v. Leake et al, which ended in September, 2007 with the State Bar defendants' dismissal as parties. In the present litigation, the State Bar defendants' motions to dismiss were denied in August. After discovery, Peters will move for summary judgment.

# **Actions Before the State Appellate Courts**

In 2008, the Office of Counsel represented the State Bar in several appellate cases.

The office represented the State Bar in appellate proceedings involving Willie Gilbert. Gilbert, whose law license was suspended by the DHC in 2000, filed a lawsuit in state court seeking to enjoin the State Bar from proceeding with a second DHC case on a separate issue of misconduct. Gilbert alleged that the Bar had violated his constitutional rights by filing the second disciplinary action. The trial court entered a permanent injunction prohibiting the Bar from pursuing its disciplinary action and reserved judgment on monetary damages and attorneys' fees. The Court of Appeals dismissed the Bar's appeal as interlocutory. The Supreme Court allowed the Bar's petition for discretionary review and heard oral argument in the case on December 11, 2007. No decision has yet been issued.

On March 18, 2008, the Court of Appeals issued its opinion in Willie D. Gilbert's second appeal from a district court judgment in favor of the State Bar. The judgment awarded double damages for funds the CSF reimbursed to Gilbert's client. The opinion rejected all of Gilbert's contentions other than his contention that the interest was calculated incorrectly. The State Bar's petition for rehearing on the interest issue was denied. The Supreme Court denied Gilbert's petition for discretionary review on December 12, 2008. A proposed judgment has been sent to the presiding district court judge.

The State Bar filed a brief as *amicus curiae* in Johnson v. Schulz, a Court of Appeals case from Cumberland County. The seller in a residential real estate transaction sued the buyer contending that the buyer rather than the seller must bear the risk of loss suffered when the buyer's closing lawyer, now disbarred Donald Parker, embezzled the buyer's loan proceeds.

The Cumberland County Superior Court entered summary judgment in favor of the buyer. The COA decision could have significant impact both on the public and on the Client Security Fund. The case is scheduled for decision without oral argument.

James Ethridge appealed a DHC order of disbarment. In February 2008, the Court of Appeals affirmed the disbarment. Ethridge did not seek further appellate review.

The State Bar is defending the appeal of Michael McGee from an order of the DHC. McGee was suspended by the DHC for five years in 2004 with the provision that he could seek a stay of the final two years on enumerated conditions. In 2008, the DHC denied McGee's petition for a stay. The case has been scheduled for decision January 28, 2009 without oral argument.

The State Bar is defending the appeal of Creighton Sossomon. In March 2008, the DHC suspended Sossomon for one year. Sossomon appealed both the underlying disciplinary order and the DHC order dismissing his appeal for failure to file the record timely. Both parties have filed their briefs and an order scheduling oral argument is expected soon.

The State Bar is defending the appeal of Robert Talford. After Talford rejected the Grievance Committee's admonition, the DHC imposed a one year suspension, with the first 60 days active. Talford appealed. The parties are working on settling the record on appeal.

### **Actions Before the Federal Courts**

The Office of Counsel was not involved in any federal litigation in 2008.






Total Calls Returned (January - December)
