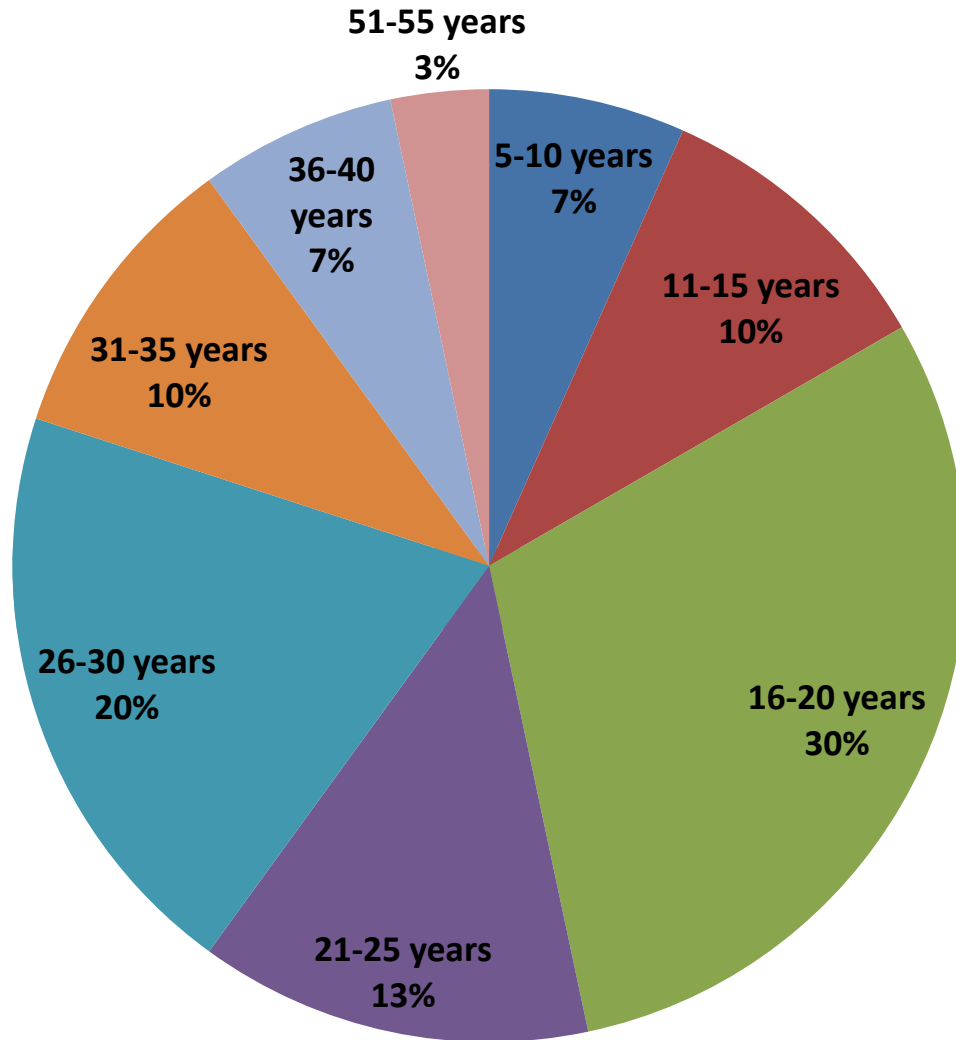

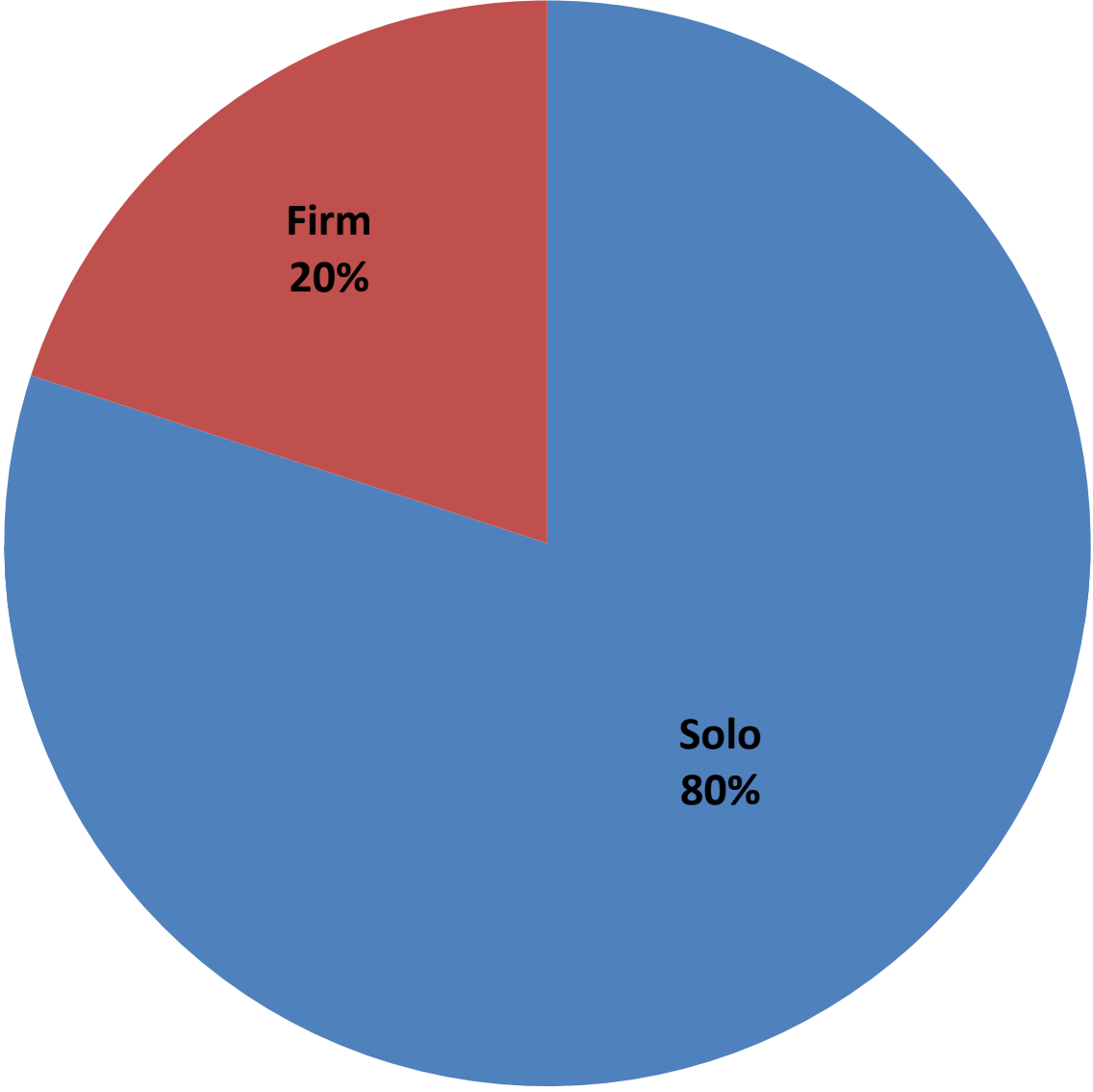

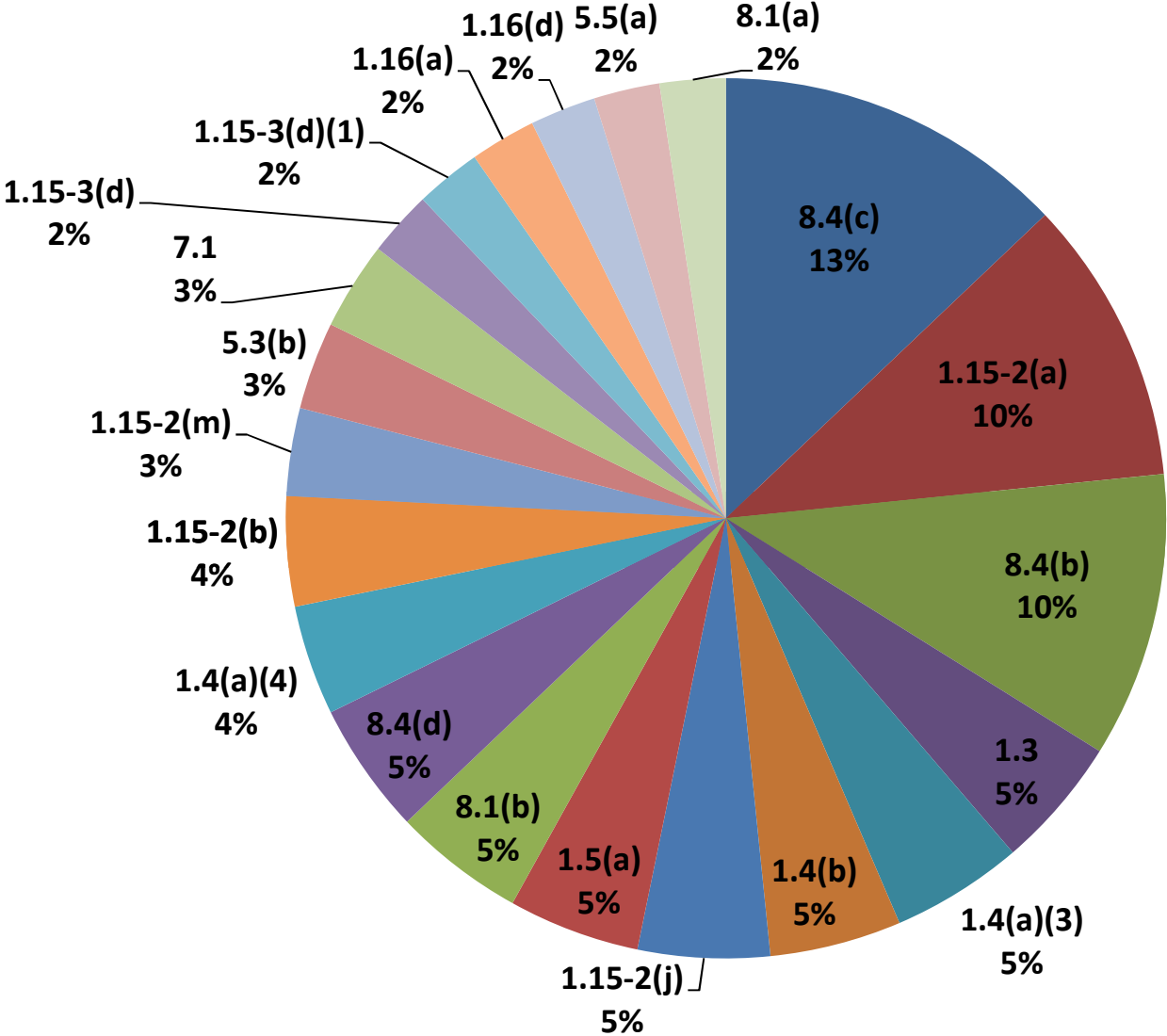
2017 DHC Orders - Years in Practice

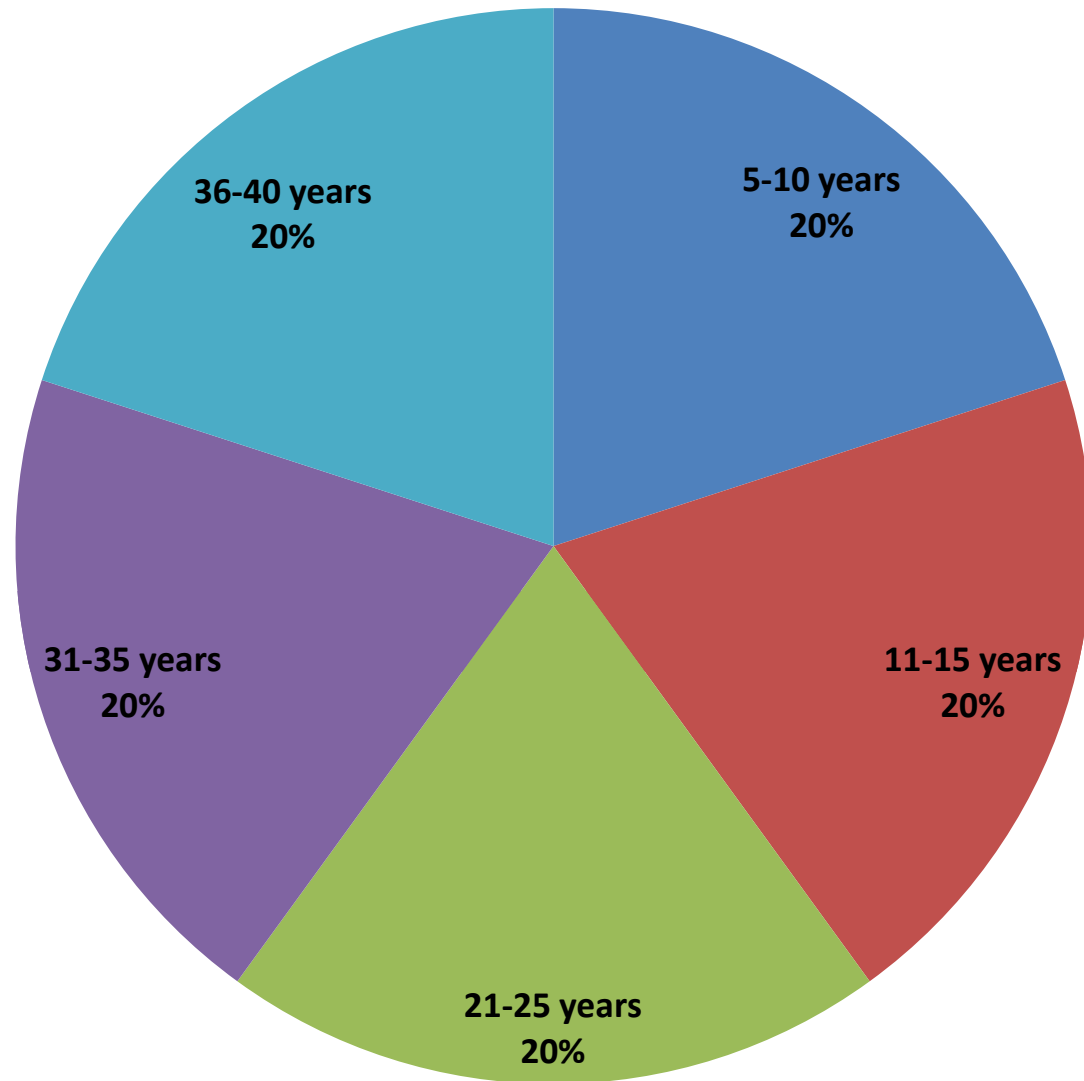

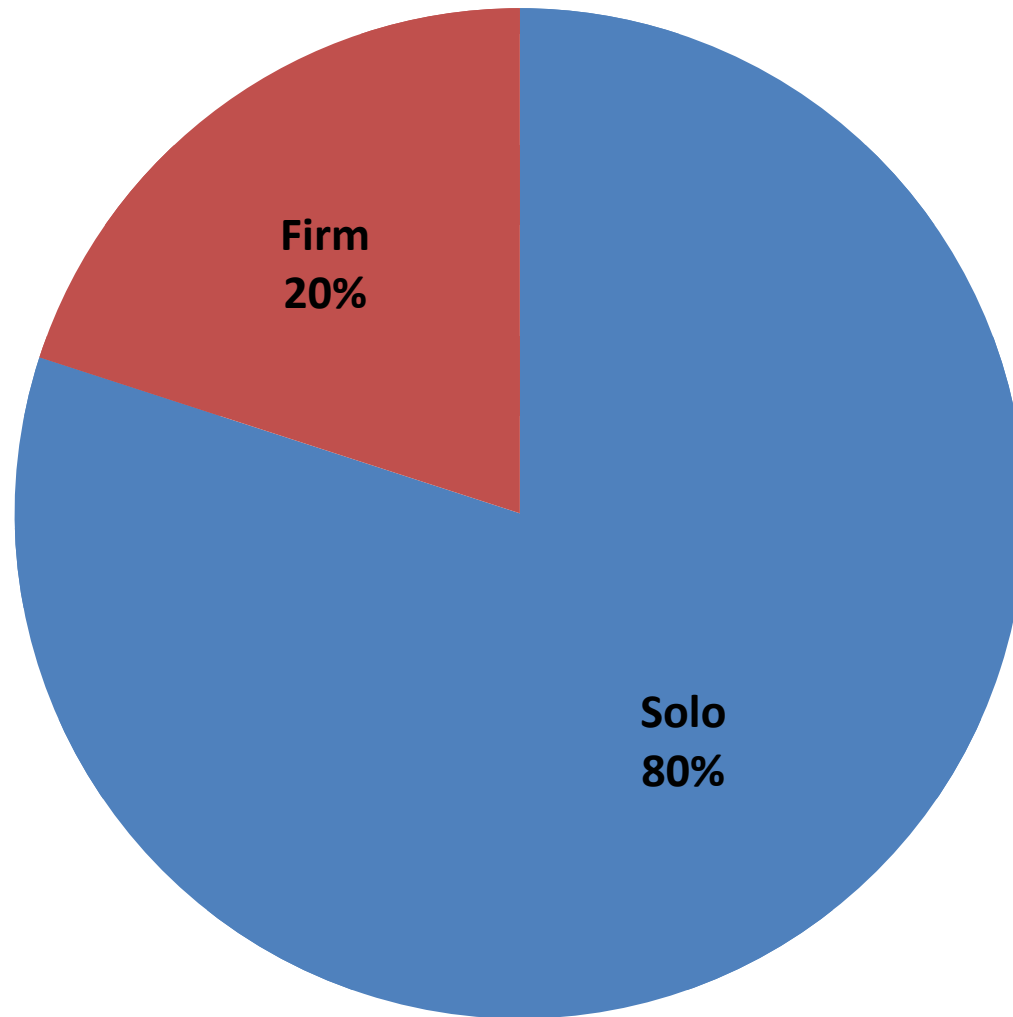

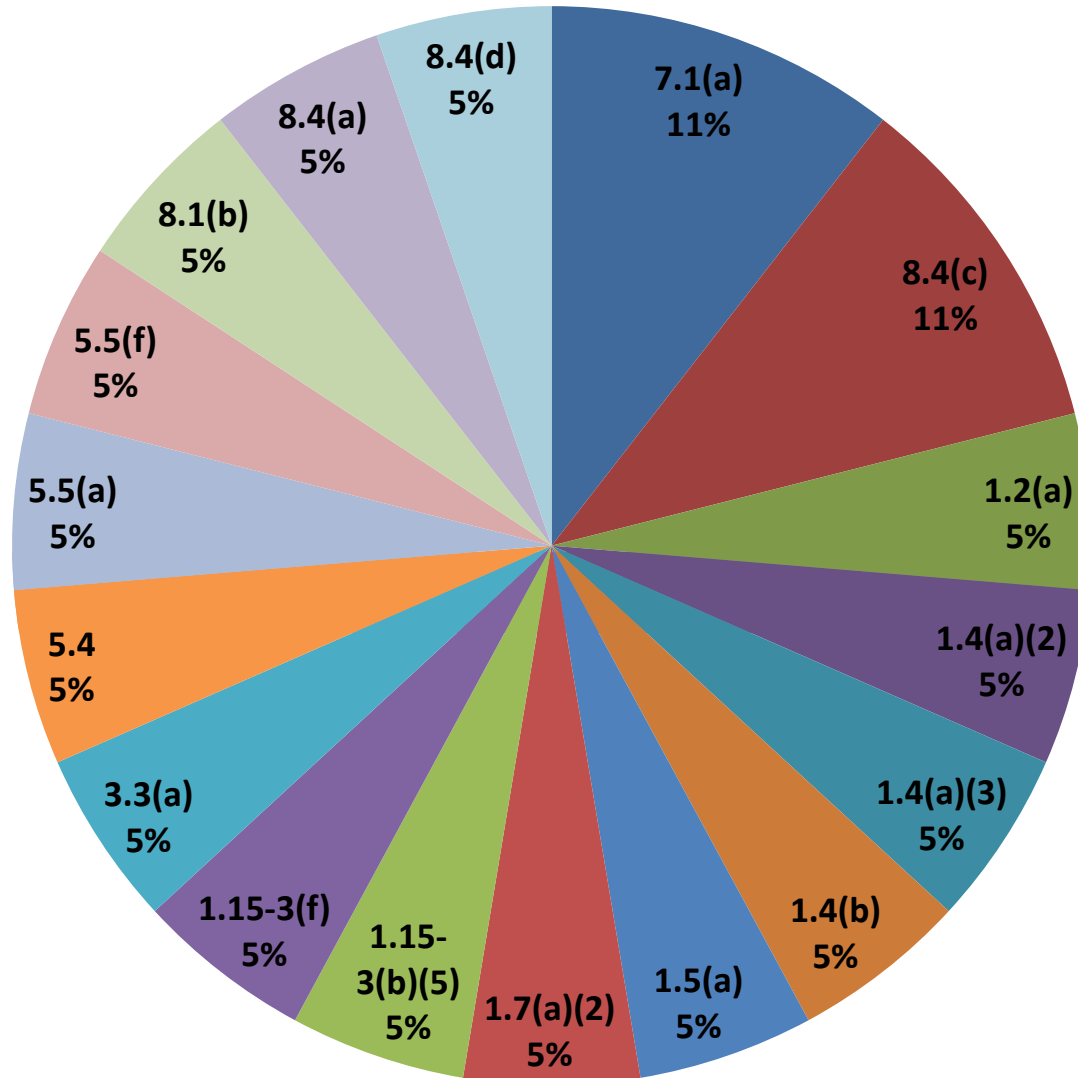
2017 Censures - Years in Practice

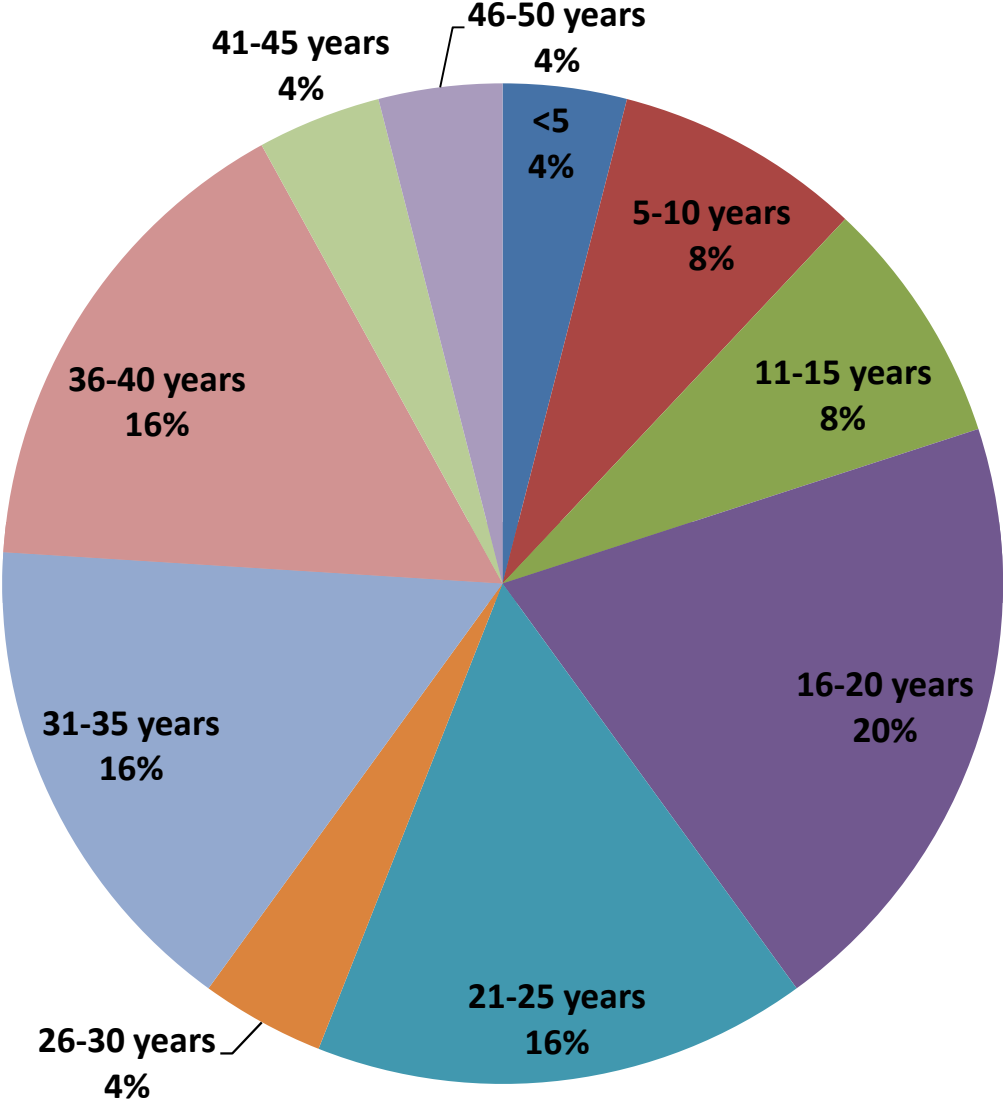

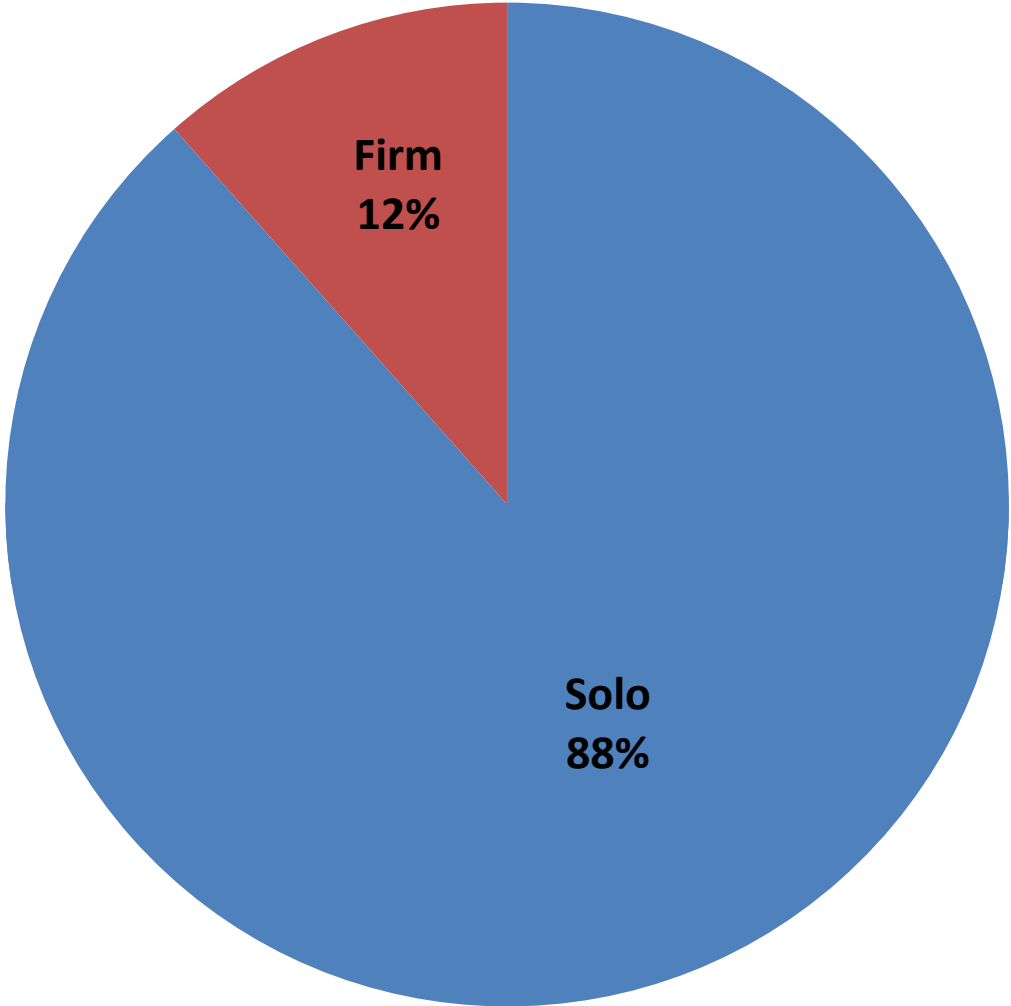

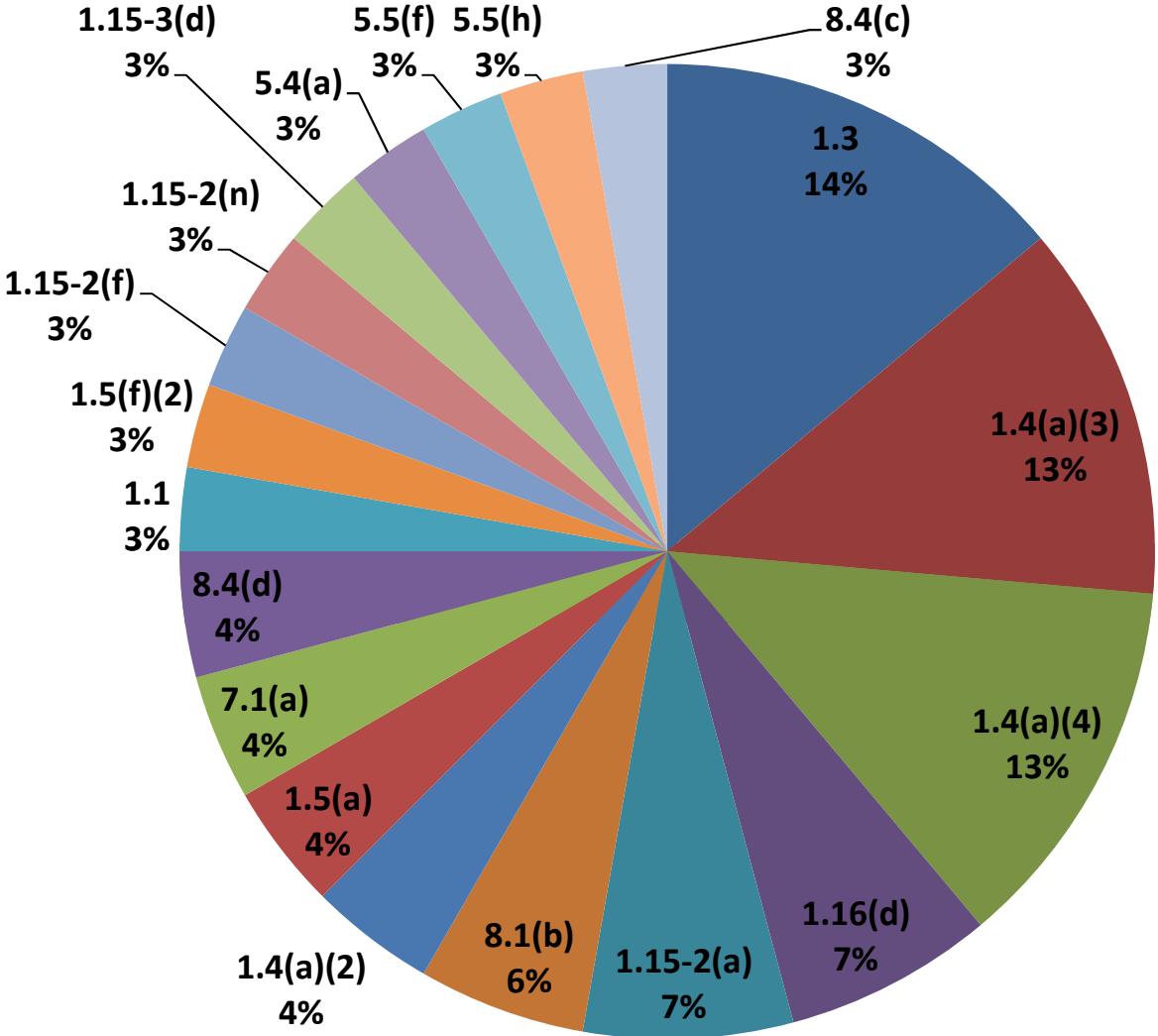
2017 Reprimands - Years in Practice

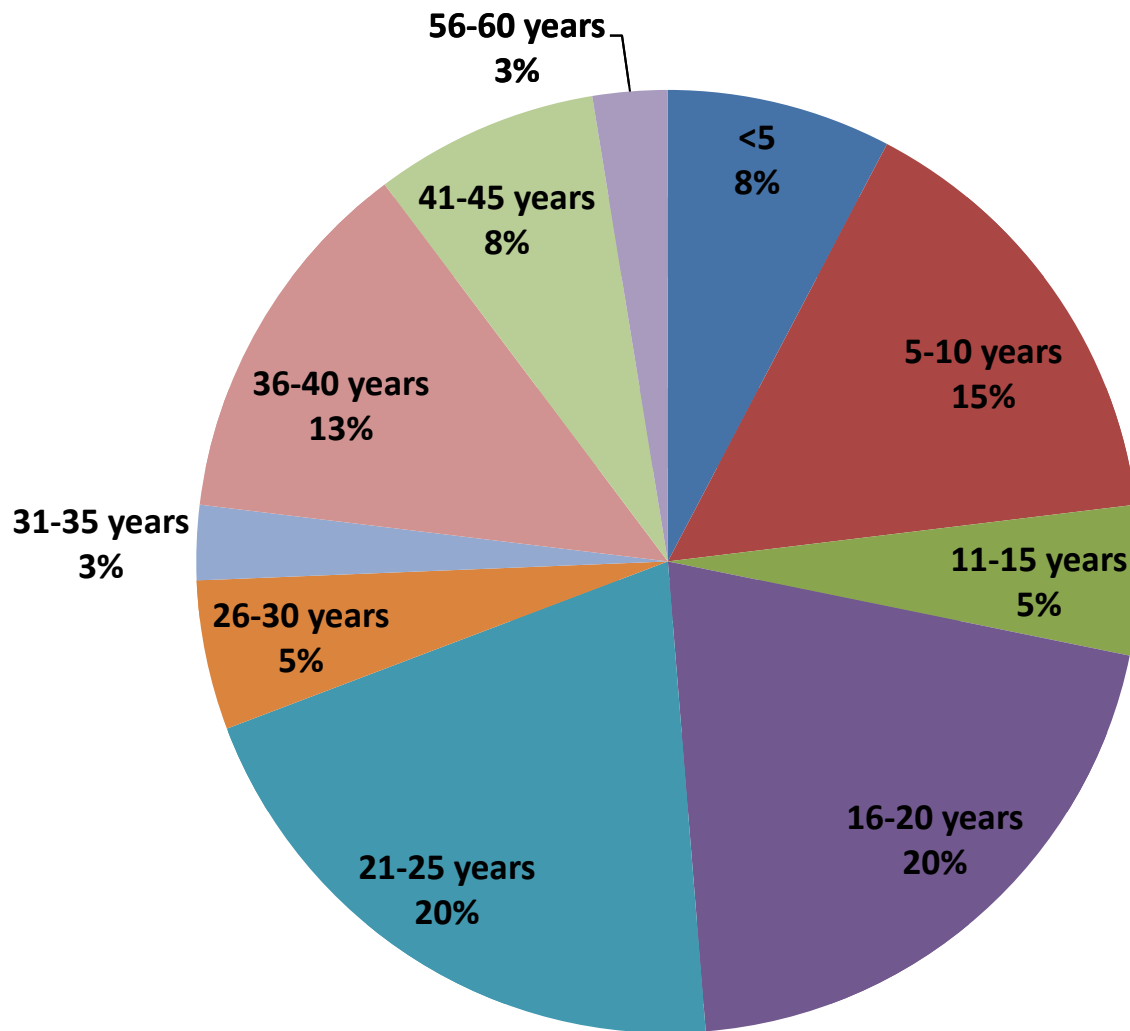

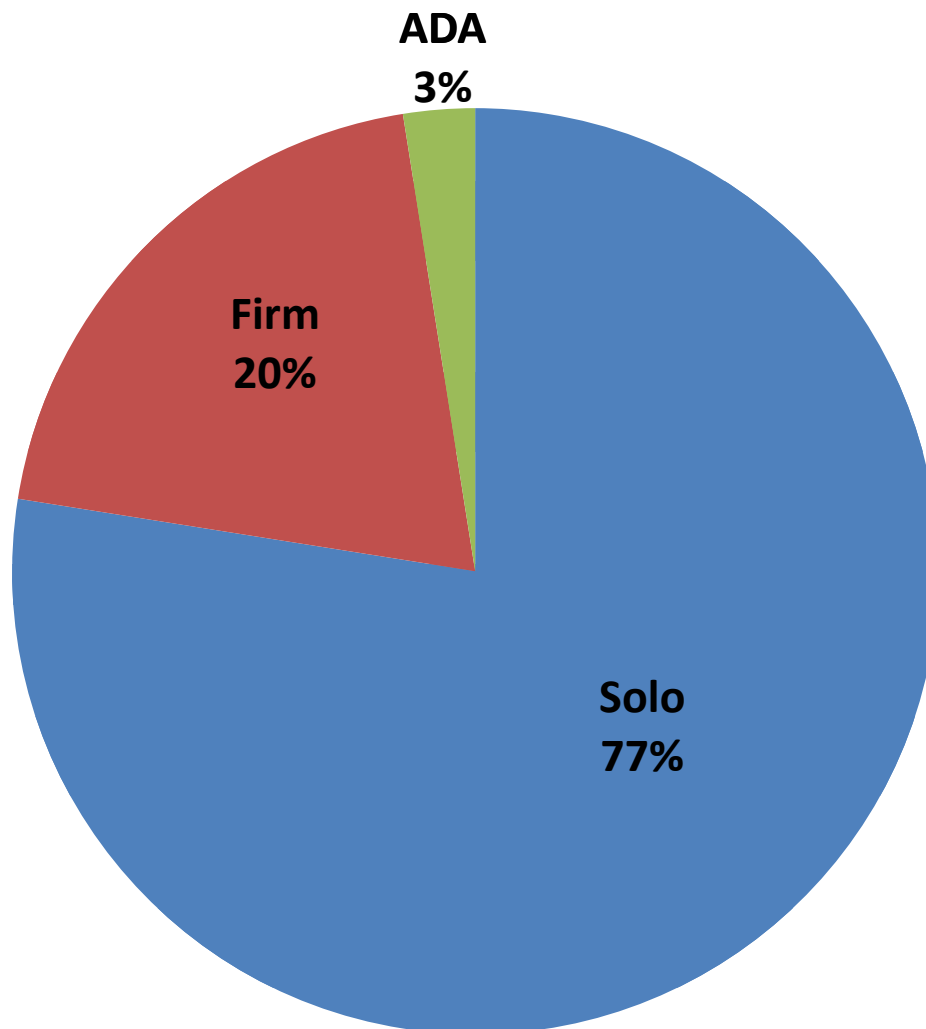

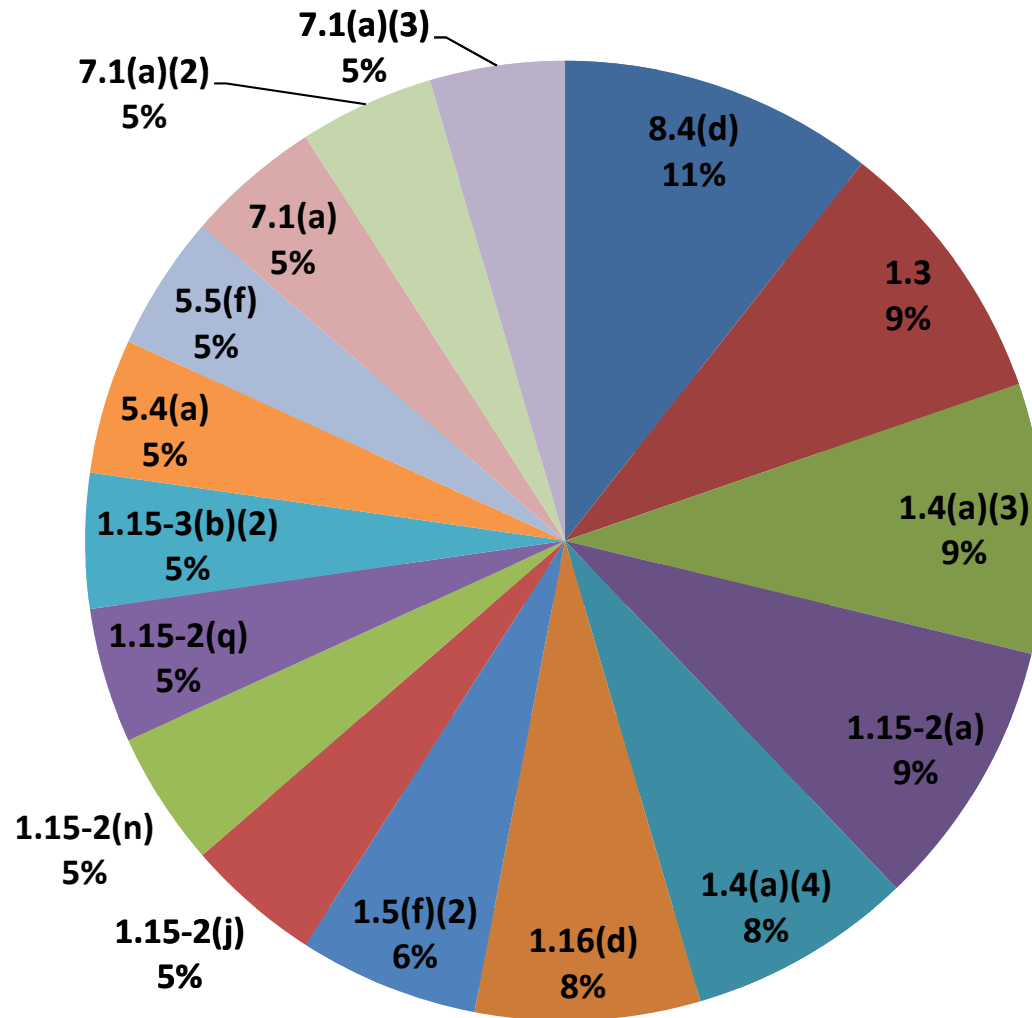
2017 Admonitions - Years in Practice

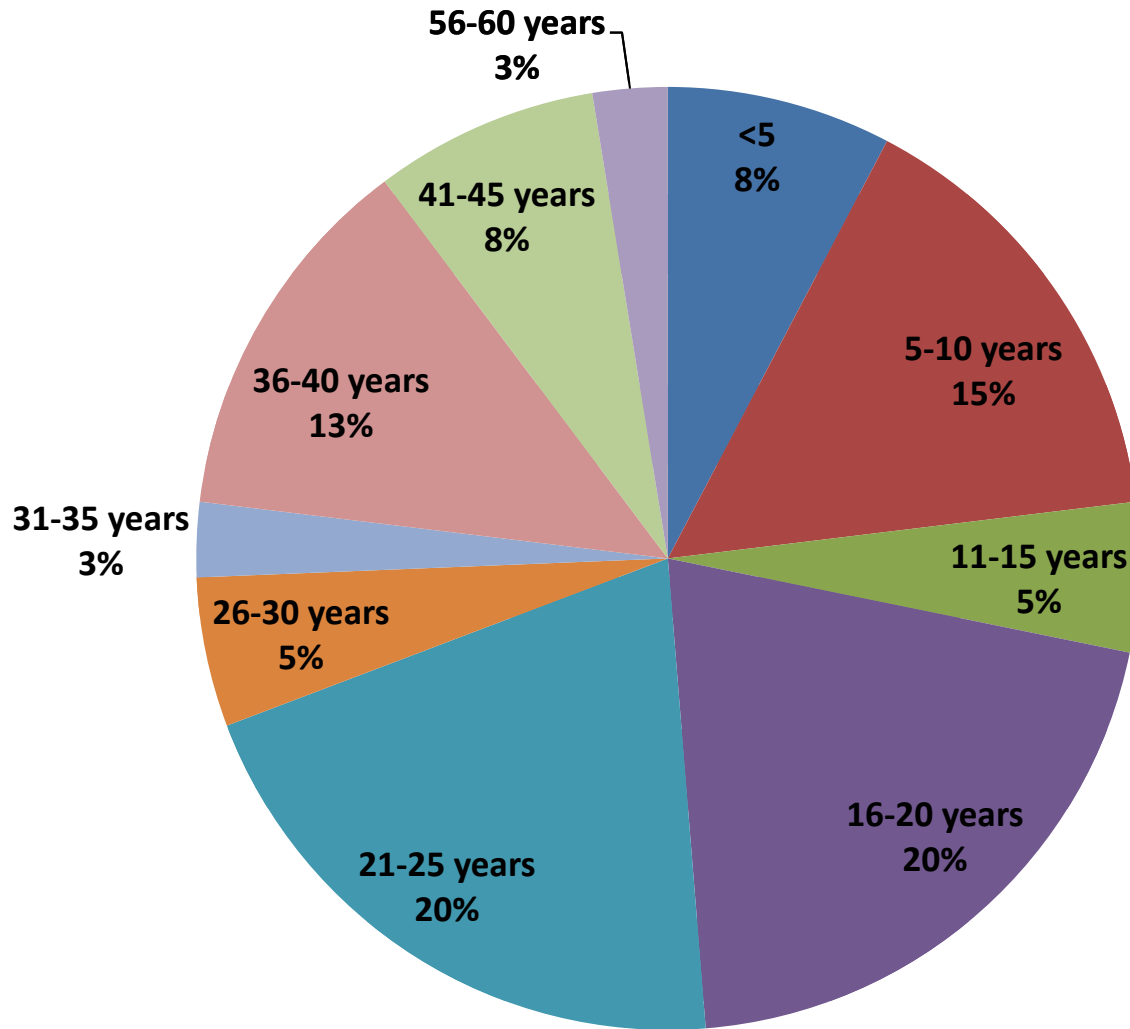

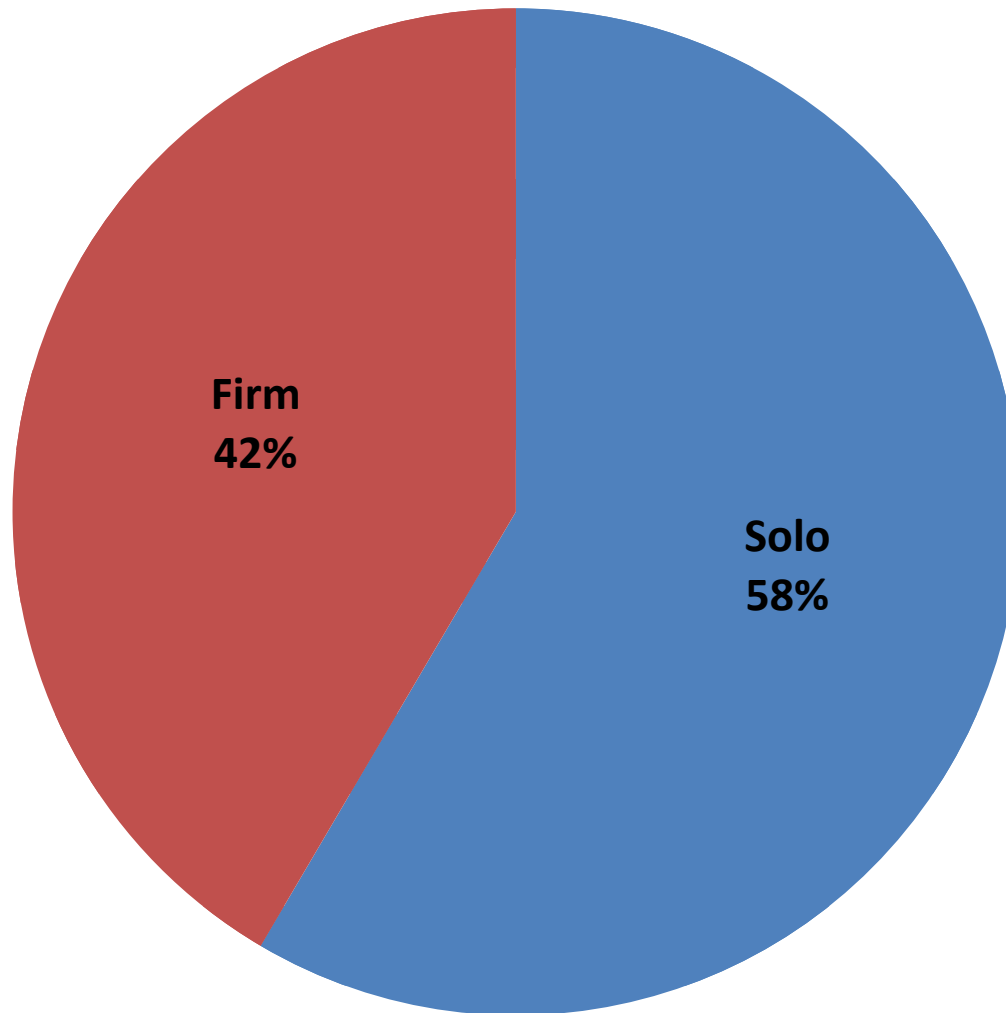

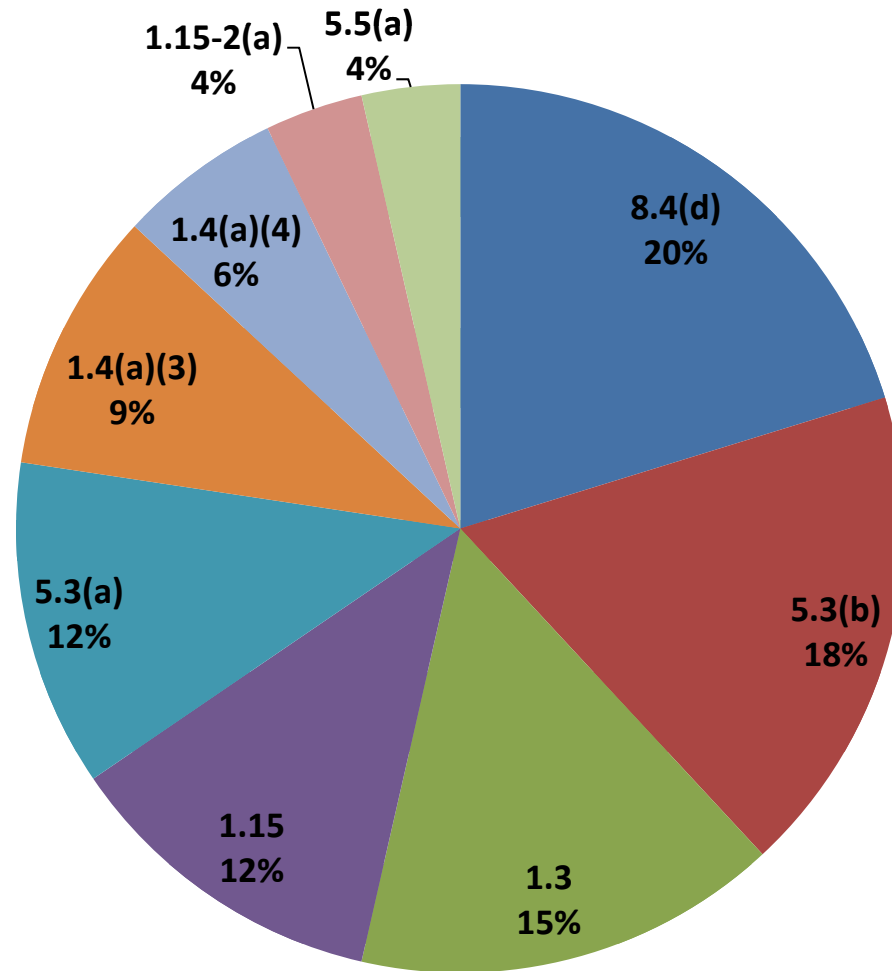
2017 Admonitions - Years in Practice

2017 Letters of Warning - Top Rule Violations



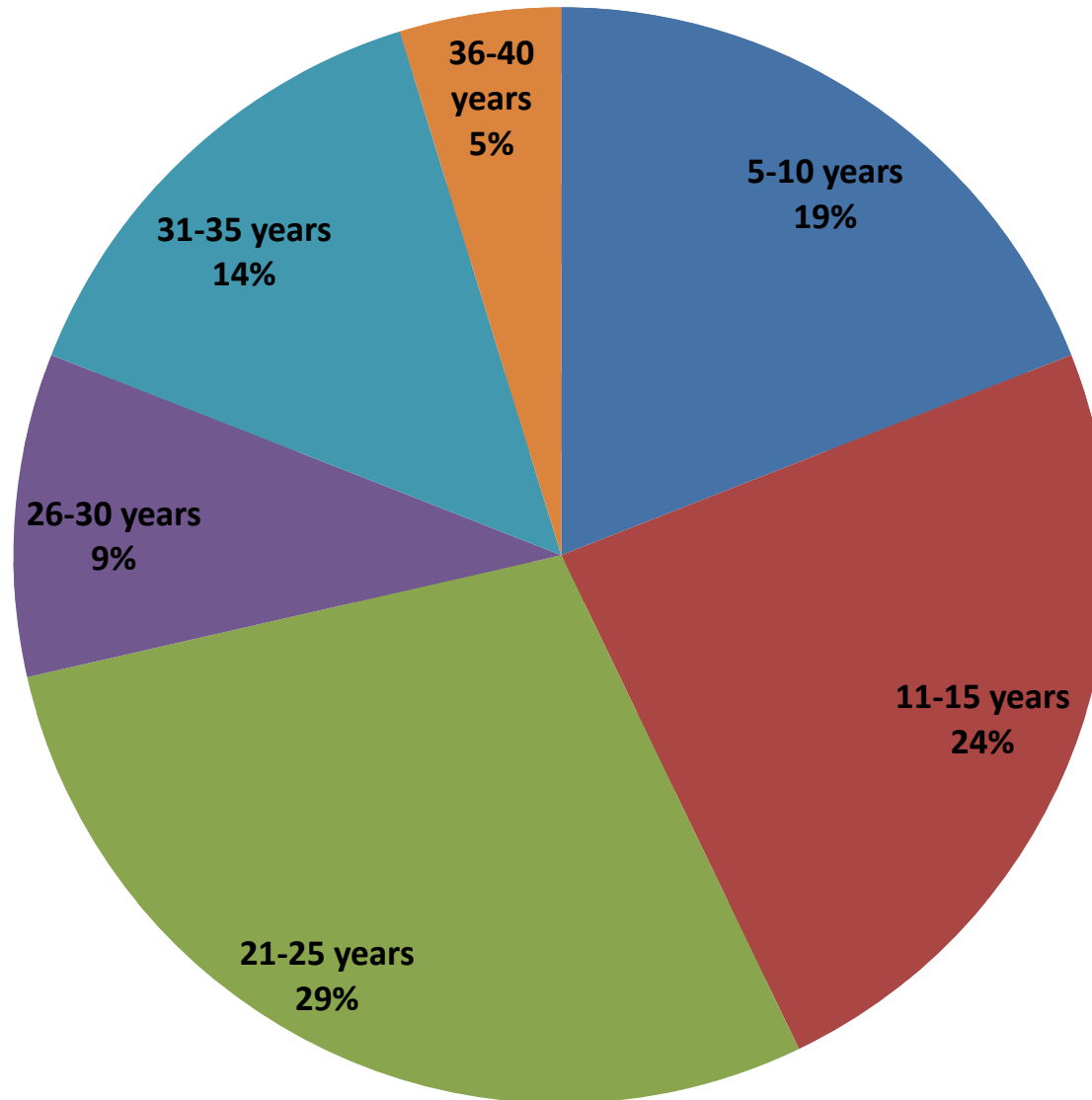

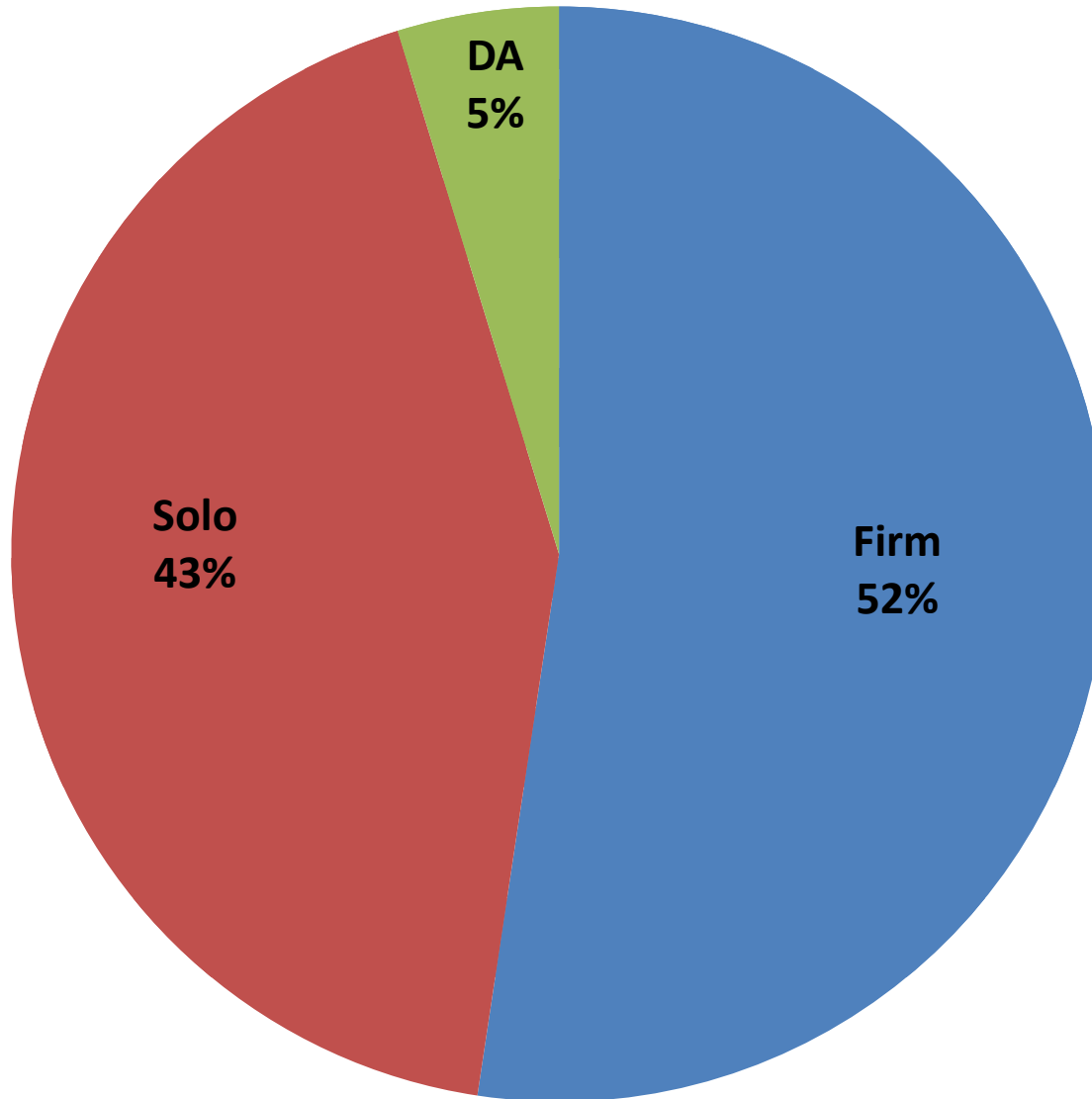

2017 Letters of Caution - Type of Practice



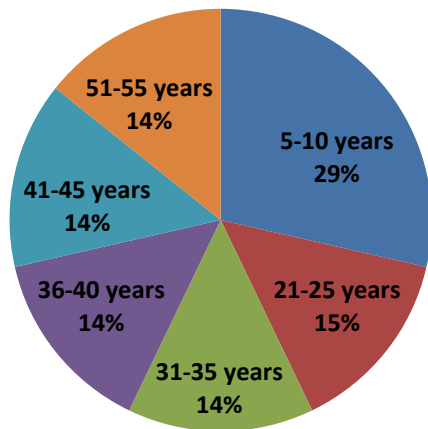
