Notes Of Interest:

1. Two cases were heard under new Rule .0135 – suspension for grievance non-compliance
2. Since the pandemic there has been 1 motion hearing that was virtual
3. Since the pandemic there has been 1 show cause hearing that was virtual
4. Since the pandemic there have been 2 hearings that were in-person with social distancing requirements – mandatory mask wearing, everyone 6 feet apart, the witness behind plexi-glass; no visitors
5. Currently there are 5 hearings scheduled – 1 is scheduled for 2 days; 1 is scheduled for 4 days
6. There are currently 6 matters that need to be rescheduled. 1 will be 3 days.
7. There are currently 10 matters that have not been scheduled. 2 of those will be 3 days and 1 will be 4 days.
8. There are 2 stayed matters – one the attorney is on disability inactive status, and one the attorney is enjoined from practicing law awaiting a disability finding.
