

**WEBSITE DOCUMENT PROVIDER
ANNUAL RENEWAL OF REGISTRATION**

Pursuant to N.C. Gen. Stat. § 84-2.2, each website document provider shall pay an annual renewal fee after the initial registration fee. **The annual renewal fee is \$50.00.**

The annual renewal fee will be due yearly in accordance with the date of the initial registration. A late notice will be sent if renewal is not submitted timely. If the payment and renewal registration are not paid by the date provided in the late notice, the registration will expire and the provider's website will be removed from the State Bar website. If a provider submits a renewal registration after its registration has expired, it will be treated as an initial registration and the \$100.00 fee will be required.

Renewal of the registration does not constitute approval by the North Carolina State Bar. The operation of the Website must comply with all pertinent laws, including the prohibition on the unauthorized practice of law in N.C. Gen. Stat. § 84-2.1-10. Registration does not constitute agreement or acquiescence by the State Bar that the operation of the Website complies with all laws including N.C. Gen. Stat. § 84-2.1 or 2.2.
