CONSENT ORDER OF REINSTATEMENT

THIS MATTER was before a hearing panel of the Disciplinary Hearing Commission composed of Brian O. Beverly, Chair, Irving L. Joyner, and Kimberly W. Stratch. Jessica M. Arnold represented Respondent, the North Carolina State Bar. Joshua T. Walthall represented the Petitioner, Peter K. Gemborys. Based upon the record in this matter and the consent of the parties, the hearing panel makes the following:

**FINDINGS OF FACT**

1. By order entered 19 May 2008, a panel of the Disciplinary Hearing Commission transferred Gemborys's law license to disability inactive status.
2. On 29 April 2024, Gemborys filed a Petition for Reinstatement to Active Status. Attached to the Petition was a report from Mary Christine Parks, MSW, LCSW, LCAS, CCS, ICAADC, ICCS, who stated her opinion that Gemborys is no longer disabled and is fit to resume the practice of law.
3. The North Carolina State Bar does not have evidence contrary to the opinion of Parks.

BASED UPON the foregoing Findings of Fact, and with the consent of the parties, the hearing panel hereby enters the following:

**CONCLUSIONS OF LAW**


1. The Disciplinary Hearing Commission has jurisdiction over the parties and subject matter in this action.
2. Gemborys has satisfied the conditions of 27 N.C.A.C. 1B .0129(c)(3) to be eligible to return to active status.

THEREFORE, the hearing panel hereby GRANTS Gemborys's Petition for Reinstatement to Active Status and enters the following:

**ORDER OF REINSTATEMENT**

1. The law license of Petitioner, Peter K. Gemborys, is hereby reinstated to active status and Petitioner may resume the practice of law.
2. This order shall be effective immediately upon entry.


