Disciplinary Action

* Attorney Thomas W. Prince of Kernersville was suspended on October 15, 1979 from the practice of law in the courts of the Appellate Division of the North Carolina General Court of Justice for a period of twelve months. He was also suspended from the practice of law in criminal cases in the Superior Court Division and in the District Court Division of the North Carolina General Court of Justice for a period of six months. The judicial disciplinary proceeding, which was held in Superior Court, Forsyth County, arose out of respondent's failure to perfect the appeal in a criminal case in which he was appointed to represent defendant.

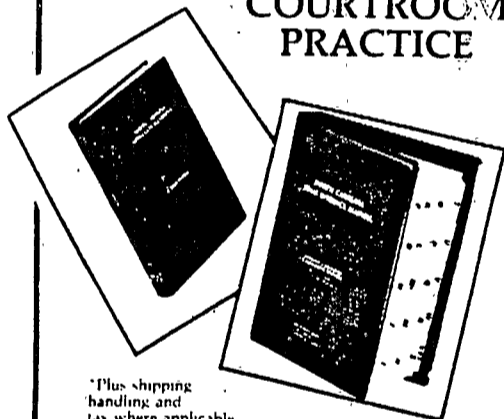
Attorney Jerome Paul formerly of Durham, who now resides in New York City, was suspended from the practice of law in North Carolina for a period of two years on November 9, 1979. A panel of the Disciplinary Hearing Commission found that Paul had neglected a legal matter entrusted to him by failing to seek appellate review of a client's case, that he intentionally failed to seek the lawful objectives of his client, that he engaged in professional conduct that adversely reflects upon his fitness to practice law, and that he failed to answer a formal inquiry in a North Carolina State Bar disciplinary matter. The suspended attorney had been retained by Gilbert Purcell in 1976 to have Mr. Purcell's manslaughter conviction reviewed by the North Carolina Supreme Court. After waiting over a year for Paul to act, Purcell, who had been confined in Central Prison, employed another attorney who successfully prosecuted the appeal which resulted in a new trial.
