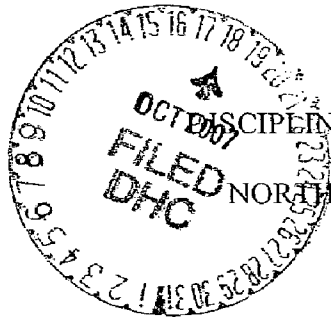

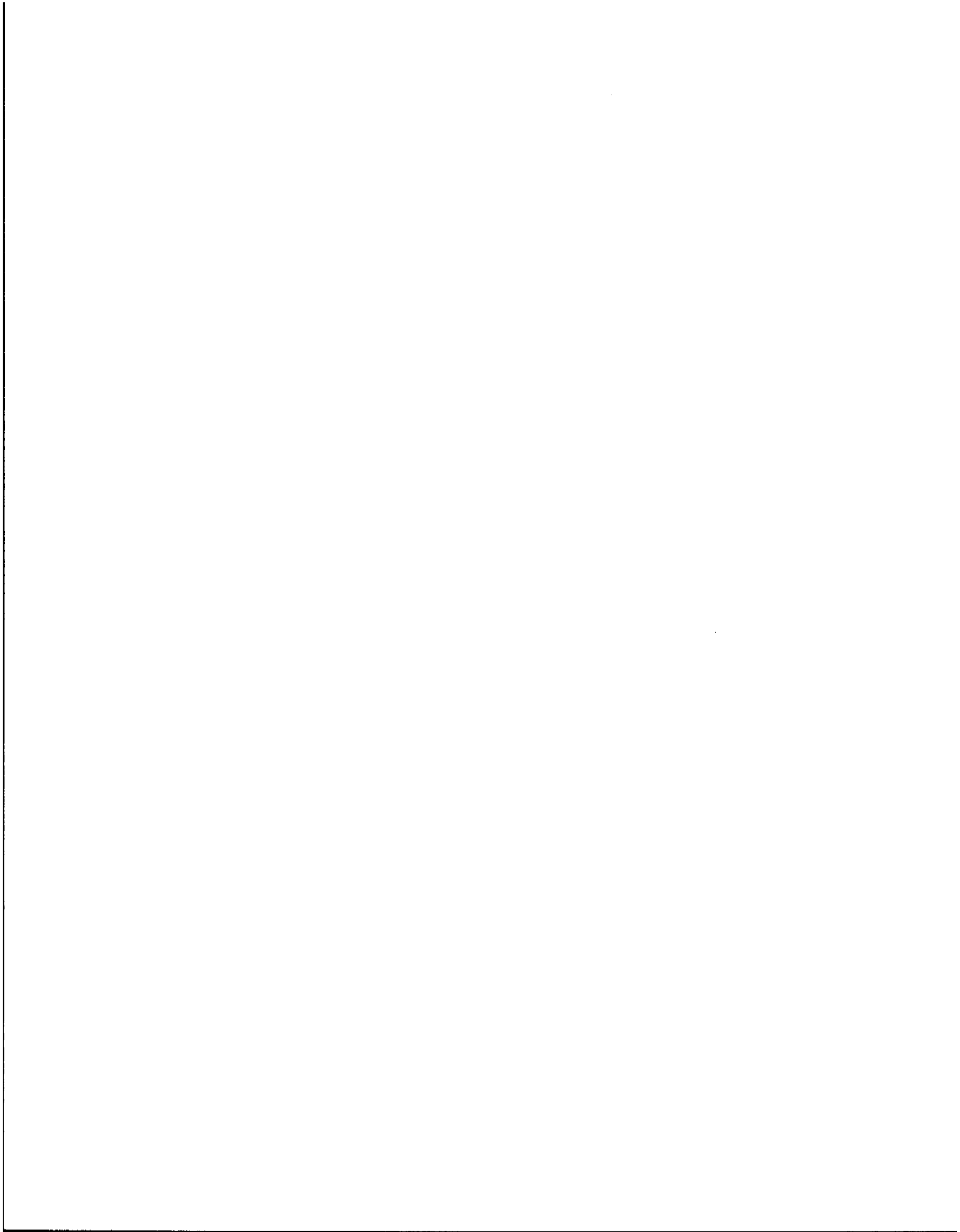
ORDER
OF DISBARMENT

THIS MATTER came on for hearing before the Chair of the Disciplinary Hearing Commission pursuant to 27 N.C.A.C. 1B §.0117(d) upon an Affidavit of Surrender of Law License executed by William C. Myers ("Myers") dated October 12, 2007 and filed in the office of the Clerk of the Disciplinary Hearing Commission on October 16, 2007.

Based upon the pleadings and the record, including the Affidavit of Surrender of Law License, the undersigned makes the following:

FINDINGS OF FACT

1. Defendant was licensed to practice law in North Carolina in 1964.
2. Defendant's address of record with the North Carolina State Bar is 3511 Buena Vista Road, Winston-Salem, NC 27106.
3. In this action, the State Bar has alleged that Myers misappropriated at least \$28,000.00 held by him in trust and utilized those funds for his own personal benefit or for the benefit of a third party without authorization from the beneficial owners of the funds.
4. In his Affidavit of Surrender of Law License, Myers admits that the facts upon which the State Bar's allegations are founded are true and that he cannot successfully defend against the allegations.
5. In his Affidavit of Surrender of Law License, Myers states that he wishes to consent to disbarment by filing an affidavit with the Disciplinary Hearing Commission.
6. The Affidavit of Surrender of Law License meets all requirements set forth in 27 N.C.A.C. 1B §.0117(a)(1), (2), (3), (4) and (d).



Based upon the foregoing Findings of Fact, the undersigned makes the following

CONCLUSIONS OF LAW

1. 27 N.C.A.C. 1B §.0108 provides that the Chair has the power and duty to enter orders disbarring members by consent.

2. Defendant's affidavit meets all requirements set forth in 27 N.C.A.C. 1B §.0117(a)(1), (2), (3), (4) and (d) and the facts upon which the affidavit is predicated warrant Defendant's disbarment.

Based upon the foregoing Findings of Fact and Conclusions of Law, the undersigned Chair of the Disciplinary Hearing Commission enters the following

ORDER

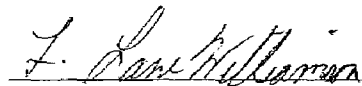
1. The surrender of the law license of William C. Myers is hereby accepted.

2. William C. Myers is DISBARRED from the practice of law in North Carolina effective upon the entry of this order with the Secretary of the North Carolina State Bar.

3. William C. Myers shall comply with the provisions of 27 N.C.A.C. 1B §.0124 of the State Bar Discipline and Disability Rules and shall surrender his license and permanent membership card to the Secretary of the North Carolina State Bar along with the affidavit required by 27 N.C.A.C. 1B §.0124 of the State Bar Discipline and Disability Rules.

4. The costs of this action are taxed against William C. Myers.
