



5. Wittenberg has engaged in professional misconduct warranting disbarment.

IT IS NOW, THEREFORE, ORDERED:


1. The surrender of the license of Lawrence Wittenberg is hereby accepted.
2. Lawrence Wittenberg is DISBARRED from the practice of law in North Carolina effective upon entry of this Order.
3. Wittenberg shall comply with the provisions of 27 N.C. Admin. Code 1B §.0128 and shall surrender his law license and permanent membership card to the Secretary of the North Carolina State Bar along with the affidavit required by Rule .0128.
4. Within 15 days of the effective date of this Order Wittenberg shall provide the State Bar with an address and telephone number at which clients seeking return of files can communicate with Wittenberg and obtain such files.
5. Wittenberg shall promptly return client files in his possession, custody, or control to clients upon request, within five days of receipt of such request. Wittenberg will be deemed to have received any such request three days after the date the request is sent to him if the request is sent to the address Wittenberg provided to the State Bar pursuant to this Order.
6. Wittenberg shall not petition for reinstatement of his law license until the expiration of at least five years from the date of entry of this order.
7. Wittenberg's law license shall not be reinstated until he has demonstrated to the satisfaction of the Disciplinary Hearing Commission and the Council of the North Carolina State Bar that he has complied with 27 N.C. Admin. Code 1B §§ .0128 and .0129(a).
8. The costs of this action are taxed against Lawrence Wittenberg.





AFFIDAVIT OF

Lawrence Wittenberg, being first duly sworn, deposes and says as follows:


1. I desire to surrender and hereby tender my license to practice law in North Carolina.
2. My surrender is freely and voluntarily rendered. It is not the result of coercion or duress. I am fully aware of the implication of submitting my surrender.
3. I am aware that there is a pending investigation by the State Bar regarding allegations that I misappropriated at least \$170,000.00 to which my law firm was entitled by cashing attorney fee checks for services performed while I was a salaried employee of the firm.
4. I acknowledge that the material facts upon which the investigation is predicated are true.
5. I am submitting my resignation because I know that if disciplinary charges were predicated upon the misconduct under investigation, I could not successfully defend against them.
