CENSURE

On October 20, 2005, the Grievance Committee of the North Carolina State Bar met and considered the grievance filed against you by C. P.

Pursuant to section .0113(a) of the Discipline and Disability Rules of the North Carolina State Bar, the Grievance Committee conducted a preliminary hearing. After considering the information available to it, including your response to the letter of notice, the Grievance Committee found probable cause. Probable cause is defined in the rules as "reasonable cause to believe that a member of the North Carolina State Bar is guilty of misconduct justifying disciplinary action."

The rules provide that after a finding of probable cause, the Grievance Committee may determine that the filing of a complaint and a hearing before the Disciplinary Hearing Commission are not required and the Grievance Committee may issue various levels of discipline depending upon the misconduct, the actual or potential injury caused, and any aggravating or mitigating factors. The Grievance Committee may issue an admonition, a reprimand, or a censure.

A censure is a written form of discipline more serious than a reprimand, issued in cases in which an attorney has violated one or more provisions of the Rules of Professional Conduct and has caused significant harm or potential significant harm to a client, the administration of justice, the profession or a member of the public, but the misconduct does not require suspension of the attorney's license.

The Grievance Committee believes that a hearing before the Disciplinary Hearing Commission is not required in this case and issues this censure to you. As chairman of the Grievance Committee of the North Carolina State Bar, it is now my duty to issue this censure. I am certain that you will understand fully the spirit in which this duty is performed.

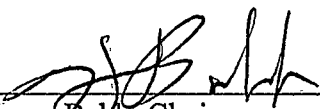
You and Attorney A were principals in Law Firm which represented C.P. in a personal injury action. When your association with Law Firm ended, you telephoned C.P. and told her that Attorney A was less experienced than you, that Attorney A did not want her case and had therefore "given" her case to you, and that C.P. needed to sign a document permitting you to obtain C. P.'s records from Attorney A. C.P. signed the document only because she believed Attorney A no longer wanted her case and had given her case to you. When C.P. later learned Attorney A had not given her case to you, C.P. signed a letter stating that she wished to remain with Attorney A. Thereafter, you repeatedly contacted C.P. trying to get her to change her mind, even telephoning C.P. and members of her family while she was in the hospital. C.P. felt it necessary

to ask the State Bar to intervene so you would cease contacting her. This conduct violates Revised Rules of Professional Conduct 4.2, 7.1(a) and 7.3 (b) and RPCs 48 and 200.

You are hereby censured by the North Carolina State Bar for your violation of the Rules of Professional Conduct. The Grievance Committee trusts that you will ponder this censure, recognize the error that you have made, and that you will never again allow yourself to depart from adherence to the high ethical standards of the legal profession. This censure should serve as a strong reminder and inducement for you to weigh carefully in the future your responsibility to the public, your clients, your fellow attorneys and the courts, to the end that you demean yourself as a respected member of the legal profession whose conduct may be relied upon without question.

In accordance with the policy adopted October 15, 1981 by the Council of the North Carolina State Bar regarding the taxing of the administrative and investigative costs to any attorney issued a censure by the Grievance Committee, the costs of this action in the amount of \$50.00 are hereby taxed to you.
