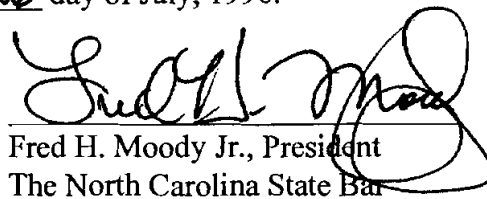
THIS MATTER coming on to be heard and being heard by the Council of the North Carolina State Bar pursuant to 27 N.C. Admin. Code Chapter 1, Subchapter B, Rule. 0117 of the Discipline and Disability Rules of the North Carolina State Bar, upon an affidavit of tender of license pursuant to Rule .0117(a) executed by Mark Reid Edmondson and filed in the offices of the North Carolina State Bar on July 5, 1996.

Based upon the affidavit, the Council finds that the conduct of Mark Reid Edmondson is grounds for discipline pursuant to N.C. Gen. Stat. Section 84-28(b)(2) in that Mark Reid Edmondson misappropriated client funds in violation of Rules 1.2(b) and (c) and 10.1(a) and (c) of the North Carolina Bar Rules of Professional Conduct.

WHEREFORE, upon motion duly made and seconded, the Council enters the following order:

1. The tender of surrender of license of Mark Reid Edmondson is hereby accepted.
2. Mark Reid Edmondson is hereby DISBARRED from the practice of law in North Carolina.
3. Mark Reid Edmondson shall forthwith surrender his license and membership card to the Secretary. He shall comply with all provisions of 27 N.C. Admin. Code, Chapter 1, Rule .0124 of the Discipline and Disability Rules of the North Carolina State Bar.
4. The costs of this action are hereby taxed against Mark Reid Edmondson.

4. I acknowledge that the material facts upon which the investigation is predicated are true.

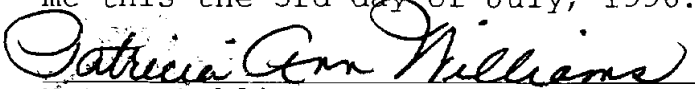
5. My resignation is being submitted because I know that if charges were predicted upon the misconduct under investigation, I could not successfully defend against them.
