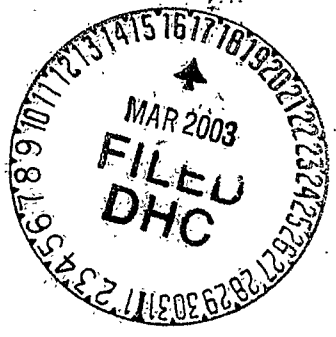

THIS MATTER is before the undersigned Chairperson of the Grievance Committee of the N.C. State Bar pursuant to 27 N.C. Admin. Code Chapter 1B, Section .0118(g). Bobby D. White represented the North Carolina State Bar and Jacqueline C. Morris-Goodson appeared pro-se. Based upon the evidence presented and with the consent of the member and the counsel, the undersigned makes the following:

FINDINGS OF FACT

1. The North Carolina State Bar is a body duly organized under the laws of North Carolina and is the proper party to consent to this proceeding under the authority granted it in Chapter 84 of the General Statutes of North Carolina and the Rules and Regulations of the North Carolina State Bar promulgated thereunder.
2. Jacqueline C. Morris-Goodson was admitted to practice law in North Carolina on August 21, 1977 and is an Attorney at Law licensed to practice in North Carolina, subject to the rules, regulations and Revised Rules of Professional Conduct of the North Carolina State Bar and the laws of the State of North Carolina.
3. Jacqueline C. Morris-Goodson actively engaged in the practice of law in the State of North Carolina and, prior to February 2003, maintained a law office in the City of Wilmington, New Hanover County, North Carolina.
4. Jacqueline C. Morris-Goodson currently suffers from a major depressive disorder, recurrent anxiety, and chronic pain syndrome, which significantly impair her professional judgment, performance or competence as an attorney.
5. Jacqueline C. Morris-Goodson consents to being transferred to disability inactive status.

BASED UPON the foregoing Findings of Fact, the undersigned makes the following:

CONCLUSIONS OF LAW

1. Pursuant to 27 N.C. Admin. Code 1B Section .0118(g), the proper parties have consented to the transfer of Jacqueline C. Morris-Goodson to disability inactive status.
2. Jacqueline C. Morris-Goodson is disabled within the meaning of 27 N.C. Admin. Code 1B Section .0103(19).

THEREFORE, it is hereby ORDERED:

1. Jacqueline C. Morris-Goodson is transferred to disability inactive status.
2. Jacqueline C. Morris-Goodson shall refrain from practicing law in North Carolina until reinstated to active status pursuant to 27 N.C. Admin. Code Chapter 1B Section .0125(c).
