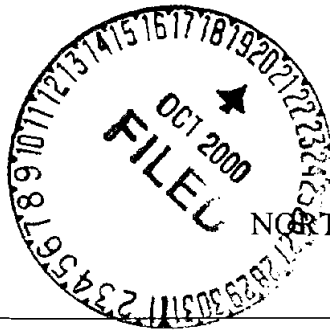


THIS MATTER coming on to be heard and being heard by the Council of the North Carolina State Bar pursuant to 27 N.C. Admin. Code Chapter 1, Subchapter B, Rule .0117 of the Discipline and Disability Rules of the North Carolina State Bar, upon an affidavit of tender of license pursuant to Rule .0117(a) executed by John B. Gladden and filed in the offices of the North Carolina State Bar on October 2, 2000.

Based upon the affidavit, the Council finds that the conduct of John B. Gladden is grounds for discipline pursuant to N.C. Gen. Stat. Section 84-28(b)(2) in that John B. Gladden misappropriated funds from his former law firm's trust account in violation of Rule 1.2(b) and (c), Rule 10.1(a) and (c), and Rule 10.2(e) of the North Carolina State Bar Rules of Professional Conduct and misappropriated funds from his former law firm's operating account in violation of Rule 1.2(b) and (c) of the North Carolina State Bar Rules of Professional Conduct and Rule 8.4(b) and (c) of the North Carolina State Bar Revised Rules of Professional Conduct.

WHEREFORE, upon motion duly made and seconded, the Council enters the following order:

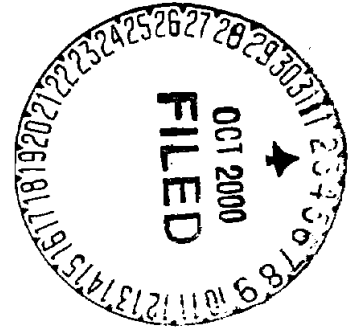
1. The tender of surrender of license of John B. Gladden is hereby accepted.
2. John B. Gladden is hereby DISBARRED from the practice of law in North Carolina.
3. John B. Gladden shall forthwith surrender his license and membership card to the Secretary. He shall comply with all provisions of 27 N.C. Admin. Code, Chapter 1, Rule .0124 of the Discipline and Disability Rules of the North Carolina State Bar.
4. The costs of this action are hereby taxed against John B. Gladden.

AFFIDAVIT
